

**THE EAST CAMBRIDGESHIRE DISTRICT COUNCIL
(OFF STREET PARKING PLACES) ORDER 2017**

East Cambridgeshire District Council ("the Council") in exercise of the powers contained in Section 32, 35 and 35A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, ("the Act"), as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and having received the consent of Cambridgeshire County Council in accordance with Section 39 (3) of the 1984 Act hereby make the following order: -

PART I

COMMENCEMENT AND CITATION

- 1 This Order shall come into operation on the 6th July 2017 and may be cited as the **East Cambridgeshire (Off Street Parking Places) Order 2017**.
- 2 (1) In this Order, except where the context otherwise requires, the expressions specified in Column 1 of Schedule 1 shall have the meanings respectively assigned to them in column 2 of that Schedule.

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if, for the purposes of Section 23 of that Act, this Order were an Act of Parliament and the Orders revoked by Article 23 of this Order were Acts of Parliament thereby repealed.

(3) For the purpose of this Order a Vehicle shall be regarded as displaying:-
 - (a) a Parking Ticket in the prescribed manner if:-
 - (i) the Parking Ticket is clearly exhibited on the dashboard or fascia of the Vehicle so that the front of the ticket and its expiry time and date are clearly visible from outside the Vehicle; or
 - (ii) where the Vehicle is not fitted with a dashboard or fascia, the Parking Ticket is exhibited in a conspicuous position on the Vehicle, so that the front of the ticket and its expiry time and date are clearly visible from outside the Vehicle.
 - (b) a Season Ticket in the prescribed manner if:-
 - (i) the Season Ticket is clearly exhibited on the dashboard or fascia of the Vehicle so that the front of the ticket and its expiry date is clearly visible from outside the Vehicle; or
 - (ii) where the Vehicle is not fitted with a dashboard or fascia, the Season Ticket is exhibited in a conspicuous position on the Vehicle, so that the front of the ticket and its expiry date is clearly visible from outside the Vehicle.

- (c) a Disabled Person's Badge in the prescribed manner if:-
 - (i) the front of the badge is clearly exhibited on the dashboard or fascia of the Vehicle so that the front of the badge and expiry date is clearly visible from outside the Vehicle; or
 - (ii) where the Vehicle is not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the Vehicle, so that the front of the badge and expiry date is clearly visible from outside the Vehicle.
- (d) a Market Permit in the prescribed manner if:-
 - (i) the front of the Market Permit is clearly exhibited on the dashboard or fascia of the Vehicle so that the expiry date is clearly visible from outside the Vehicle; or
 - (ii) where the Vehicle is not fitted with a dashboard or fascia, the Market Permit is exhibited in a conspicuous position on the Vehicle so that the expiry date is clearly visible from outside the Vehicle.
- (e) a Business Permit in the prescribed manner if:-
 - (i) the front of the Business Permit is clearly exhibited on the dashboard or fascia of the Vehicle so that the number of the permit and expiry date is clearly visible from outside the Vehicle; or
 - (ii) where the Vehicle is not fitted with a dashboard or fascia, the front of the permit is exhibited in a conspicuous position on the Vehicle, so that the number of the Business Permit and expiry date is clearly visible from outside the Vehicle.

- (1) In addition to the provisions of Article 2(3), payment for the relevant parking charge may be made using the Cashless Payment Parking System.
 - (2) Where a Vehicle has been left in a Parking Place and payment has been made by the Cashless Payment Parking System, a Parking Attendant shall have information with regards to the payment made and parking period for that particular Vehicle.
 - (3) If no indication appears on the Hand-held Device that payment of the relevant parking charge has been made using the Cashless Payment Parking System or the period for which the payment was made has expired it shall be presumed that either:
 - (i) The relevant parking charge has not been duly paid in respect of that Vehicle; or
 - (ii) The parking period for which the payment was made by the Cashless Payment Parking System has expired

And in either case the Parking Attendant may serve a Penalty Notice Charge.

4. The restrictions, prohibitions and requirements imposed by this Order are in addition to and not in derogation from any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption to the provisions of this Order is without prejudice to the provisions of any other enactment. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
5. Except where otherwise stated, any reference in the Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

PART II

USE OF PARKING PLACES

Manner in which Vehicles shall be parked

6. Subject to the provisions of this Order, each Parking Place specified by name in Column (1) of Schedule 2 to this Order may be used as a Parking Place for such classes of Vehicles, in such positions, and on such conditions, on such days and during such hours as are specified column 4 in Schedule 2.
7.
 - (1) Where in Schedule 2 a Parking Place is described as available for Vehicles of a specified class or in a specified position the Driver of a Vehicle shall not permit it to wait in the Parking Place unless it is of the class and in a position specified.
 - (2) Where an area of any Parking Place described in Schedule 2 there is a sign or similar marking which indicates that a Parking Bay is available only for a Disabled Person's Badge holder's only, the Driver of a Vehicle shall not permit it to wait in the Parking Bay unless the Vehicle is either driven or occupied as a passenger by the holder of a Disabled Person's Badge in the manner described in Article 2(3) (c).
 - (3) Where an area of any Parking Place described in Schedule 2 there is a sign or similar marking which indicates that a Parking Bay is available only for Motor Cycles only, the Driver of a Vehicle shall not permit it to wait in the Parking Bay unless it is a Motor Cycle.
 - (4) The Driver of a Vehicle shall not permit the Vehicle to wait in any Parking Place unless the Vehicle is in such state or condition that it may be driven away from the Parking Place, including onto the public highway, at any time during the stay.
 - (5) Where an area of any Parking Place described in Schedule 2 there is a sign or similar marking which indicates that a Parking Bay is available only for Coaches only, the Driver of a Vehicle shall not permit it to wait in the Parking Bay unless it is a Coach.
 - (6) Where an area of any Parking Place described in Schedule 2 there is a sign or similar marking which indicates that a Parking Bay is available only for Market Permit holders only, the Driver of a Vehicle shall not permit it to wait in the Parking Bay unless it is a Market Vehicle.

8. The Driver of a Vehicle shall not permit it to wait in a Parking Place for longer than the maximum period permitted for waiting specified in column (4) of Schedule 2.
9. The Driver of a Vehicle using a Parking Place shall park only in places set aside for that purpose and shall not obstruct the access-ways, park at the end of a row, on a walkway or on the grass except upon the direction or with permission of a Parking Attendant.
10. Where a Parking Place is marked out in Parking Bays, the Driver of a Vehicle shall not park otherwise than as indicated by those markings.
11. (1) Where, within a Parking Place, there is a sign or surface marking which indicates that a Parking Bay is available only for Disabled Person's Vehicle, for use by a Disabled Person's badge holder, the Driver of a Vehicle shall not permit it to wait in that Parking Bay unless it is displaying a Disabled Person's Badge and Parking Ticket in the manner described in Article 2 (3) (c).
- (2) Where, within a Parking Place, there is a sign or surface marking which indicates that a Parking Bay is available only for a certain class of Vehicle, or for a limited period of time and for a specified purpose or Drivers satisfying certain conditions, the Driver of a Vehicle shall not permit it to wait in that Parking Bay or for more than the specified limited period of time unless the Vehicle is of the specified class or the Driver satisfies the certain conditions.

Method and amount of payment of Initial Charges

12. (1) The Driver of any Vehicle parking in a Parking Place, not being exempt under Article 40 shall on leaving the Vehicle in the Parking Place, pay the appropriate charges as set out in Schedule 2, and for the whole duration that the Vehicle is parked in the Parking Place, by the tendering of the appropriate charge in accordance with Schedule 2.
- (2) If the Driver finds that the nearest ticket machine has failed or is out of use, then the ticket must be purchased from an alternative machine if there is one available within that Parking Place.
- (3) The charge shall be payable by insertion of an appropriate coin or coins in a Ticket Machine and the Driver shall exhibit the Parking Ticket on the Vehicle in accordance with the provisions of paragraph (5) of this Article; or
- (4) By means of a Cashless Payment by a Registered Driver, in those Parking Places where a notice or notices are displayed stating that such a facility is available; and
- (5) The Driver of the Vehicle shall exhibit on the Vehicle any Parking Ticket issued on payment of the charge referred to in paragraph (3) of this Article in the manner described in Article 2 (3) (a) and shall ensure that the ticket shall remain visible at all times for the whole duration that the Vehicle is parked in the Parking Place; or
- (6) Where the Vehicle is not displaying a ticket, has paid the appropriate fee in accordance with the manner described in Article 3 (2)

And in either case in accordance with the conditions and instructions displayed in the Parking Place.

Pre-payment of Charges by way of a Business Permit or Market Permit

13. The Owner or Driver of a Vehicle may on application to the Council purchase a Business Permit or Market Permit in respect of that Vehicle in accordance with the charges specified in Schedule 2 in any Parking Places where Business Permits and Market Permits are available as specified in Schedule 2 and provided that such Business Permit or Market Permit is validly displayed as set out in Article 2(3) (d) and (e) on the Vehicle for which it was purchased and in the Parking Place for which it was issued and in the period for which it was issued.

Pre-payment of Charges by way of a Season Permit

14. The Owner or Driver of a Vehicle may on application to the Council purchase a Season Ticket in respect of that Vehicle in accordance with the charge specified in Schedule 2 in any Parking Places where a Season Ticket are available as specified in Schedule 2 and provided that such Season Ticket is validly displayed as set out in Article 2 (3) (b) on the Vehicle for which it was purchased and in the Parking Place for which it was issued and in the period for which it was issued, then the Driver of the Vehicle shall be exempt from payment of any other initial charge or the display of a ticket issued by a machine under the provisions of Article 11.

Validity of Parking Tickets

15. The Parking Ticket referred to in Article 2 (3) shall be valid only in respect of the period for which it was issued and for the Parking Place for which it is issued and the Vehicle for which it is first displayed in and it shall be an offence for the Parking Place ticket to be transferred between Vehicles or between Parking Places.

Amount of Excess Charge payable where appropriate

16. Whether or not any initial charge has been paid in accordance with Articles 10 or 11, an excess charge shall become due and payable if the Vehicle left in the Parking Place contravenes any of the following Articles:-

Article 7:	incorrect Class of Vehicle
Article 8:	parking longer than the permitted period
Article 9:	parking in a prohibited area or obstructing access ways
Article 10:	parking outside marked bays
Article 11:	parking in a disabled person's bay without a disabled person's badge displayed on the Vehicle as indicated in Article 2(3)(c).
Article 12:	failure to pay the charge or display the parking ticket or overstaying or displaying an invalid parking ticket
Article 13:	failure to display the Business Permit or Market Permit
Article 14:	failure to display the Season Ticket
Articles 2 & 15:	failure to display a valid parking ticket in the manner specified or displaying a parking ticket transferred from another Vehicle

- (2) Where a Vehicle is left in a Parking Place in a manner that contravenes Articles 6 to 15, or otherwise in contravention of this order then a Penalty Charge Notice of £60 shall be payable PROVIDED THAT if within fourteen days following the date when notice of such Penalty Charge Notice is issued as provided in this Article the Driver tenders the sum of £50 then such latter sum may be accepted by the Council in satisfaction of the Penalty Charge Notice.
- (3) In the case of a Vehicle in respect of which excess charges may have been incurred the Parking Attendant will attach to the Vehicle in a conspicuous position a notice ("Penalty Charge Notice") giving the following particulars: -
- (a) the make and registration mark of (or the number of the trade licence plate carried by) the Vehicle;
 - (b) the date and time at which the Penalty Charge Notice was issued and the location in which the excess charge was incurred
 - (c) the reason for the alleged contravention specified in Schedule 3 for issuing the Penalty Charge Notice ;
 - (d) a statement that the Penalty Charge Notice of £60 is required to be paid;
 - (e) the manner in which and the time within which the Penalty Charge Notice should be paid or the lesser sum of £50 may be tendered as provided in Article 16(2); and
 - (f) a statement that it is an offence under Section 35A (1) to contravene or not comply with any provision of this Order.
- (4) In the event of any contravention of, or non-compliance with, the provisions of this Order the person responsible shall be liable on summary conviction to a fine not exceeding the maximum penalty prescribed by Section 33 of and Schedule 2 to the Road Traffic Offenders Act 1988 and the Council may institute proceedings against such person.
17. When a notice has been attached to a Vehicle in accordance with Article 16 (3), no person other than a person authorised by the Council in that respect or the Driver or a person authorised by the Driver in that behalf shall remove the notice from the Vehicle.

Manner of payment of excess charge

18. The registered owner of a Vehicle in respect of which the excess charge has been incurred shall pay the excess charge, as described in Schedule 2, to the Council by using one of the methods of payment stipulated on the information given on the Penalty Charge Notice. If the registered owner of the Vehicle was not the Driver of the Vehicle at the time of the offence it is the responsibility of the owner of the Vehicle to supply details of who the Driver was. Such payment to reach East Cambridgeshire District Council not later than 1 pm on the twenty-eighth day or within the time period stated in Article 16 (2) in the event of a reduced excess charges following the day on which the excess charge was incurred provided that, if the twenty-eighth day or the time limit for paying a reduced excess charge falls upon a day on which the said offices are closed, the period within which payment of the

excess charge shall be made, shall be extended to the next working day on which the said offices are open for business.

Obtaining details of the Driver

19. Where an excess charge has not been paid within the time limits set out in Article 16, the Council may take such steps as are reasonable (including application to the Driver and Vehicle Licensing Authority) to determine the Driver of the Vehicle responsible for the contravention of or non-compliance with the Order. Where any person who it seems to the Council is the registered owner or Driver of the Vehicle at the time of the offence fails to supply details of the Driver at the time of the offence than it shall be an offence under S112 of the Act of 1984.
20. Any person who wilfully avoids or seeks to avoid, or assists in avoiding the payment of the appropriate charge at any Parking Place shall be guilty of an offence under this Order.

General conduct of Drivers in Parking Places

21. When a Parking Place is under the control of a Parking Attendant the Driver of a Vehicle using or wishing to use the Parking Place shall obey the instructions of the Parking Attendant as to the parts of the Parking Place at which he or she may not park.
22. No person shall use a Vehicle, while it is in a Parking Place, in connection with the sale of any article to persons in or near the Parking Place or in connection with the selling or offering for hire of his skill or services or for any form of advertisement.
23. No person shall use any part of a Parking Place or any Vehicle left in a Parking Place:
 - (a) for sleeping or camping; or
 - (b) for eating or cooking purposes; or
 - (c) to light or cause or permit to be lit any fire; or
 - (d) washing any Vehicle or part thereof; or
 - (e) for the purpose of servicing, repair, maintenance other than is reasonably necessary to enable that Vehicle to depart from the Parking Place.
24. A person using the Parking Place, other than an officer of the Council or a person or servant of a person employed by the Council in or about any work authorised by the Council shall not: erect or cause to be erected in the Parking Place any advertisement board or any tent, awning, hut or other structure. Neither shall any leaflet, notice or paper be affixed to any Vehicle in the Parking Place or handed out to any users of the Parking Place within the area of the Parking Place.
25. No person shall use a Vehicle, while it is in a Parking Place, in connection with the sale of any article to persons in or near the Parking Place or in connection with the selling or offering for hire of his skill or services, or otherwise in connection with any trade or business.

26. The Driver of a Vehicle using the Parking Place shall stop the engine as soon as the Vehicle is in position in the Parking Place and shall not start the engine except when about to change position of the Vehicle in or to depart from the Parking Place.
27. No person shall, in the Parking Place, disconnect or cause to be disconnected any trailer from any Vehicle without the consent of the Council.
28. No person shall except with the permission of any person duly authorised by the Council drive any Vehicle in a Parking Place other than for the purposes of leaving that Vehicle in the Parking Place in accordance with the provisions of this Order or the instructions of the duly appointed person or for the purpose of departing from the Parking Place.
29. No person shall in a Parking Place wantonly shout or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or residents of premises in the neighbourhood.
30. No person shall in a Parking Place use any threatening, abusive or insulting language, gesture or conduct with intent to put any person in fear or so as to occasion a breach of the peace or whereby a breach of the peace is likely to be occasioned.
31. No person shall use a Parking Place as a means of passage for proceeding in a Vehicle from one Parking Place to another.
32. Where in a Parking Place signs are erected or surface markings are laid for the purpose of: -
 - (a) indicating the entrance to or exit from the Parking Place; or
 - (b) indicating that a Vehicle using the Parking Place shall proceed in a specified direction within the Parking Place.

no person shall drive or cause or permit to be driven any Vehicle (i) so that it enters the Parking Place otherwise than by an entrance, or leaves the Parking Place otherwise than by an exit, so indicated, or (ii) in a direction other than as specified as the case may be, except by express prior written agreement with the Council for the purpose of gaining access to or from or of loading or unloading goods or passengers at any premises adjoining the Parking Place.

33. No person shall use or permit to be used in a Parking Place a Motor Vehicle dangerously, carelessly or in an inconsiderate manner or in such a way as to cause any excessive noise which could have been avoided by the exercise of reasonable care on the part of the Driver.
34. The Council shall not be liable in respect of loss of or damage to any Vehicle or the fittings or contents of any Vehicle waiting or moving in, or entering or leaving, or otherwise using a Parking Place.

Power to adjust or suspend the use of Parking Places

35. Nothing in this Order shall restrict the power of the Council to close a Parking Place or part thereof temporarily, or to suspend charges temporarily at its discretion or to modify the layout or adjust the limits as expedient for good management of any Parking Place.
36. A Council Parking Attendant or other person authorised by the Council may suspend the use of a Parking Place or any part thereof whenever he considers such suspension reasonably necessary:-
- (1) (a) for the purpose of facilitating the management and enforcement, movement of traffic in or around the Parking Place, or promoting its safety in case of emergency; or
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the Parking Place or the maintenance, improvement or reconstruction of the Parking Place or the laying, erection, alteration, removal or repair in or adjacent to the Parking Place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line or traffic sign.
- (2) Any person suspending the use of a Parking Place or any part thereof in accordance with the provisions of paragraph (1) of this Article shall place or cause to be placed in or adjacent to any part of that Parking Place, whether or not it indicates a parking bay, and the use of which is suspended, a traffic sign and/or cones indicating that waiting by Vehicles is prohibited.

Removal of Vehicles

37. When a Vehicle is left in a Parking Place in contravention of Articles 6,7,8,9,10,11,12,13,14 of this Order a person authorised in that respect by the Council may remove the Vehicle or arrange for it to be removed from that Parking Place PROVIDED THAT when a Vehicle is waiting in a Parking Place in contravention of the provisions of Articles 6,7,8,9,10,11,12,13,14 such person may alter or cause to be altered the position of the Vehicle in order that its position shall comply with that provision
38. Any person removing or altering the position of a Vehicle by virtue of Article 37 may do so by towing or driving the Vehicle or by taking such other measures as may be reasonably necessary to enable him to remove it or alter its position
39. (1) For the purpose of meeting the requirements of an emergency, a person authorised in that respect by the Council or a Police Constable in uniform may alter or cause to be altered the position of a Vehicle in a Parking Place or remove or arrange for the removal of a Vehicle from a Parking Place.
- (2) Any person altering, or causing the alteration of, the position of a Vehicle or removing, or causing the removal of, a Vehicle by virtue of paragraph (1) of this Article may do so by towing or driving the Vehicle or in such other manner as he may think reasonably necessary to enable the position of the Vehicle to be altered or the Vehicle to be removed.

40. Any person removing or arranging for the removal of a Vehicle by virtue of Articles 37, 38 and 39 shall make such arrangements as he considers reasonably necessary for the safety of the Vehicle in the place to which it is removed.

PART III

EXEMPTIONS FROM TIME LIMITS

- 41 The following Vehicles, when left in any Parking Place described in Schedule 2 shall be exempt from the provisions relating to the maximum period for parking in a Parking Place or specified provided that:

- (1) (a) an Invalid Carriage
- (b) a Vehicle issued to a disabled person by the Department of Social Security in lieu of an invalid carriage;
- (c) a Disabled Person's Vehicle which displays in the relevant position a Disabled Person's Badge issued by any local authority.

PROVIDED THAT such exemption shall apply only if the following conditions are complied with: -

- (i) the Vehicle is left in a Parking Bay reserved for the Vehicles of Disabled Persons unless all such bays are already occupied in which case the Vehicle may be left in another bay;
 - (ii) the Vehicle is either driven or occupied as a passenger by the holder of the Disabled Person's Badge; and
 - (iii) the Disabled Person's Badge is displayed in the relevant position on the Vehicle
- (2) Vehicles in use for Police, Fire or Ambulance purposes by the emergency services, while dealing with an emergency, shall be exempt from the provisions of this Order.
 - (3) Any Motorcycle left in a designated motorcycle parking space by the rider thereof, shall not be subject to any maximum period or charges displayed.
 - (4) Any Coach left in a designated Parking Bay, shall be subject to the maximum period displayed.
 - (5) Approved Market Vehicles, when used in accordance with the terms of their Market Permit, shall be exempt from the provisions contained herein relating to the maximum period for parking provided the Market Permit is displayed as directed and all other conditions of issue are complied with.
 - (6) Vehicles, when used in accordance with the terms of a relevant Business Permit, shall be exempt from the provisions contained herein relating to the maximum period for parking provided the Business Permit is displayed as directed and all other conditions of issue are complied with.
42. The Driver of a Vehicle to which paragraphs (1), (2), (3), (4), (5) and (6) of Article 41 applies shall comply with the other provisions of this Order where appropriate regulating the use of the Parking Place.

43. If at the time when a Vehicle is left during the permitted period in a Parking Bay there is, on the nearest ticket machine to that bay a notice placed by any person duly authorised by the Council indicating that the said ticket machine is out of order then a ticket shall be obtained from another machine in accordance with Article 11 (2). However, if at the time when a Vehicle is left during the charging period in a parking bay there are on all ticket machines notices placed by any person duly authorised by the Council, indicating that the said ticket machines are out of order, that Vehicle shall be exempt from the initial charge provided that it is removed in accordance with the Limited Period of the Parking Place charging next day after any of the said ticket machines is restored to working order; if it is not removed within that period, the initial charge shall be treated as having been incurred and paid at the time when the Vehicle was left in the parking bay and all the provisions of Part II of the Order shall apply accordingly.

Revocations

44. The provisions of the East Cambridgeshire (Off-Street Parking Places) Order 2013 are hereby revoked.

SCHEDULE 1

1. Expression	2. Meaning
Business Permit	A permit issued by the Council on such terms and/or conditions as it shall decide permitting the holder to park in such Parking Places, excluding private approach roads/access areas, as has been specified in the granting of the permit;
Cashless Payment	Means a payment made using the Cashless Payment Parking System.
Cashless Payment Parking System	Means a system to facilitate and monitor the payment of parking charges using communication with the Service Provider in accordance with the instructions indicated on signs located at each Parking Place where the system is in operation.
Classes of Vehicle	The Classes of Vehicle permitted to use the Parking Places as set out Schedule 2.
Coaches	Includes any Vehicle constructed for the carriage of passengers which does not fall within the definition of Motor Vehicle contained below.
Council	East Cambridgeshire District Council.
Day and Hours Available	The Parking Places in Schedule 2 shall be available for use in compliance with this Order on all days of the year and during all hours subject to the other provisions of this Order
Disabled Person	A person more than 2 years old and falling within at least one of the prescribed descriptions in Regulation 4 of the Disable Person (Badge for Motor Vehicles) (England) Regulations 2000.
Disabled Person's Badge	Any badge issued, or having effect as if issued under any regulations for the time being in force under section 21 of the Chronically Sick and Disabled Persons Act 1970.
Disabled Person's Vehicle	A Vehicle lawfully displaying a disabled person's badge.
Driver	The person driving a Vehicle at the time when it is left in a Parking Place. Where a separate person acts as a steersman of a Vehicle it includes that person as other engaged on the driving of the Vehicle.
Ely Market Days	Every Thursday and Saturday and such other days as designated by the Council and approved by Cambridgeshire County Council.
Excess Charge	Such charge as specified in Article 16(2) to this order in relation to each Parking Place which becomes payable in addition to any initial charge upon breach of certain provisions of this Order.
Hand-held Device	Means a wireless hand-held computer used by a Parking Attendant which is programmed to interface with the Cashless Payment Parking System.
Initial Charge	A charge as specified in Column 5 of Schedule 2 to this Order in relation to each Parking Place specified in this Order.
Invalid Carriage	A mechanically propelled Vehicle of which the weight unladen does not exceed 254 kilograms and which is specially designed and constructed, and not merely adapted, for the use of a person suffering from some physical default or disability and is used solely by such a person.
Limited Period	The maximum period which a Driver shall permit his Vehicle to be parked in the Parking Place in Schedule 2.

Market Permit	A permit issued by the Council on such terms and/or conditions as it shall decide permitting an authorised Market Trader to park in such a Parking Place, excluding private approach roads/access areas, as has been specified in the granting of the permit.
Market Vehicle	A mechanically propelled Vehicle in use for the purpose of transporting goods for sale or display at Ely Markets on Ely Market Days displaying a valid Market Permit on such terms and/or conditions issued by East Cambridgeshire District Council and shall be as follows: Smaller Market Vehicle - its length does not exceed 5.3 metres; Larger Market Vehicle - its length exceeds 5.3 metres its height exceeds 2.5 metres, including any roof rack or luggage box.
Method of collection – pay and display	The method of collection of the initial charge shall be either by way of a coin ticket machine which produces a ticket showing the date and time of expiry and Parking Place of issue and by display of the ticket on the Vehicle windscreen as provided for in this Order or such other means of payment permitted by the Council. Alternatively the method of collection of the initial charge shall be pre-payment by way of Season ticket in accordance with Article 14.
Motor Cycle	A mechanically propelled Vehicle (not being an invalid carriage) with fewer than 4 wheels, of which the weight unladen does not exceed 410 kilogrammes.
Motor Home	A mechanically propelled Vehicle designed or adapted for human habitation, for the avoidance of doubt this excludes Caravans which is any structure designed or adapted for human habitation which is capable of being moved from one place to another whether by being towed or be being transported on a Motor Vehicle or Trailer.
Motor Vehicle	Has the same meaning as that assigned to "motor Vehicle" in section 136(1) of the 1984 Act
Owner	Same meaning as section 142(1) of the Act.
Parking Attendant	A person duly authorised by on or on behalf of the Council to supervise or enforce any Parking Place.
Parking Bay	An area of a Parking Place which is provided for the leaving of a Vehicle.
Parking Device	The same meaning as section 51(4) of the Act.
Parking Place	Any of those areas of land the situations of which are described in Column 1 of Schedule 2 to this Order provided by this Council under section 32 of the act 1984 for use as a Parking Place.
Parking Ticket	A ticket issued by a Ticket Machine relevant to that area indicating payment of a charge, the period in which it is paid and the day and time at which the charge was paid in accordance with the charging regime in Schedule 2 to this Order.

Penalty Charge Notice	A charge payable to the Council applied in accordance with the provisions of this Order for the commission of an offence detailed in Schedule 3
Permitted Period	The maximum period permitted for waiting in a Parking Place as specified
Registered Driver	Means a Driver of a Vehicle who has, prior to leaving his or her Vehicle in a Parking Place, registered so many of his or her personal details with a Service Provider as that Service Provider may require to enable the Cashless Payment Parking System to be activated in favour of the said Driver.
Season Ticket	A pre-paid ticket issued by the Council, indicating the Parking Place for which it is valid and the period of time for which it is valid.
Service Provider	Means the company authorised and appointed by the Council to operate, administer and maintain the payment of parking charges using the Cashless Payment Parking System
Service Vehicles	Includes Vehicles for the purpose of loading and unloading of goods and services to premises on the Cambridgeshire Business Park.
Shopmobility	The Ely Shopmobility service operating Thursday to Saturday from the Ely Museum in Market Street.
Specified charge for parking	Means the fee payable for parking in a Parking Place as displayed on or adjacent to the ticket machine relating to that Parking Place.
Ticket Machine	Means an apparatus of a type and design approved by the Secretary of State for Transport for the purposes of this Order being apparatus designed to indicate the time by a clock and to issue numbered tickets indicating the payment of the initial charge, the period in respect of which it has been paid and the day and time at which the charge was paid.
Trailer	A vehicle drawn by a 'Vehicle' as specified below
Vehicle	A Motor Vehicle of a class specified in Column 3 of Schedule 2 to this order in relation to a Parking Place provided that <ul style="list-style-type: none"> a) its length does not exceed 5.3 metres; b) its height does not exceed 2.5 metres, including any roof rack or luggage box but excluding c) Invalid Carriage; and d) Motorcycles; and e) Motor Home

Ely - Plan A



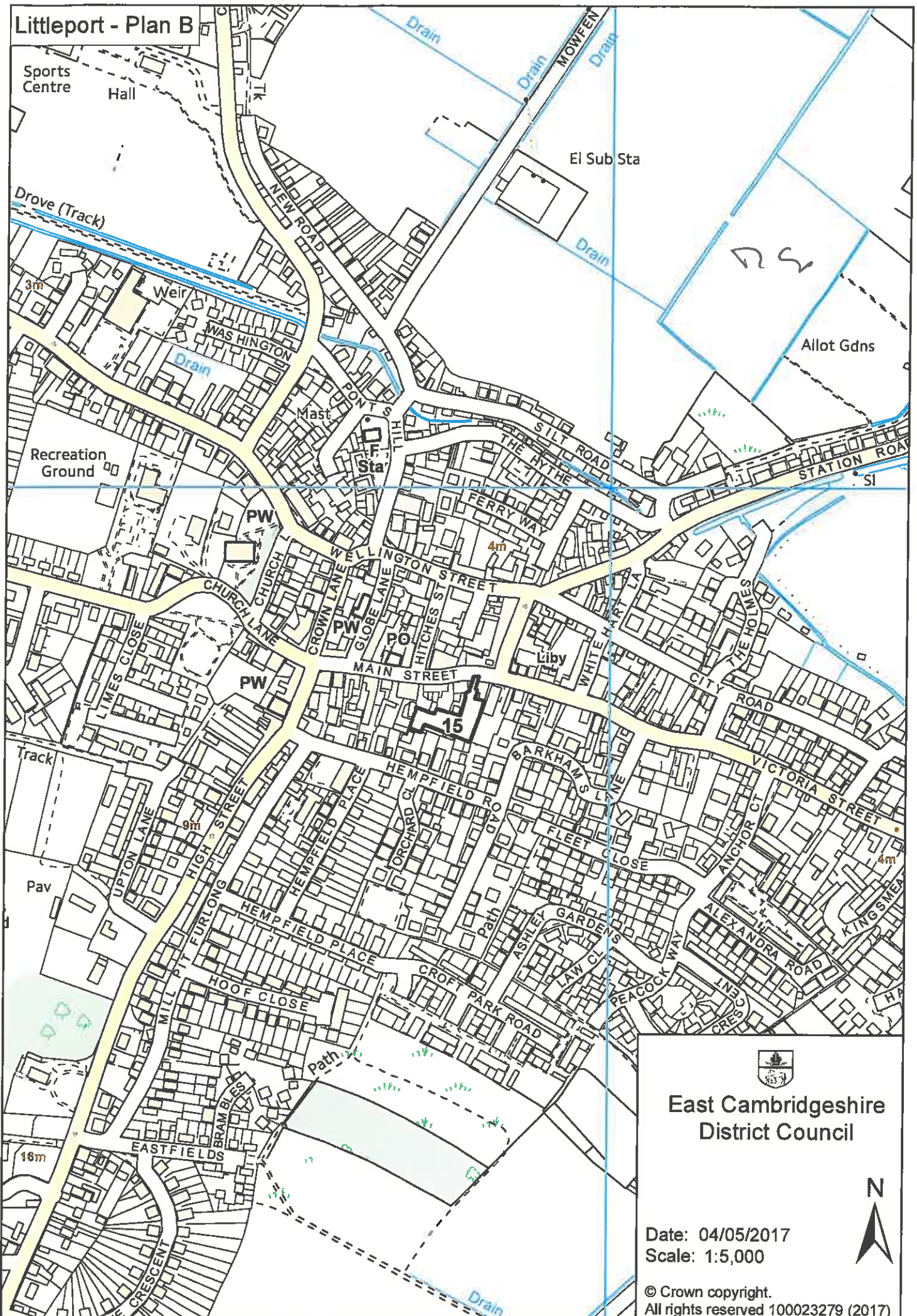

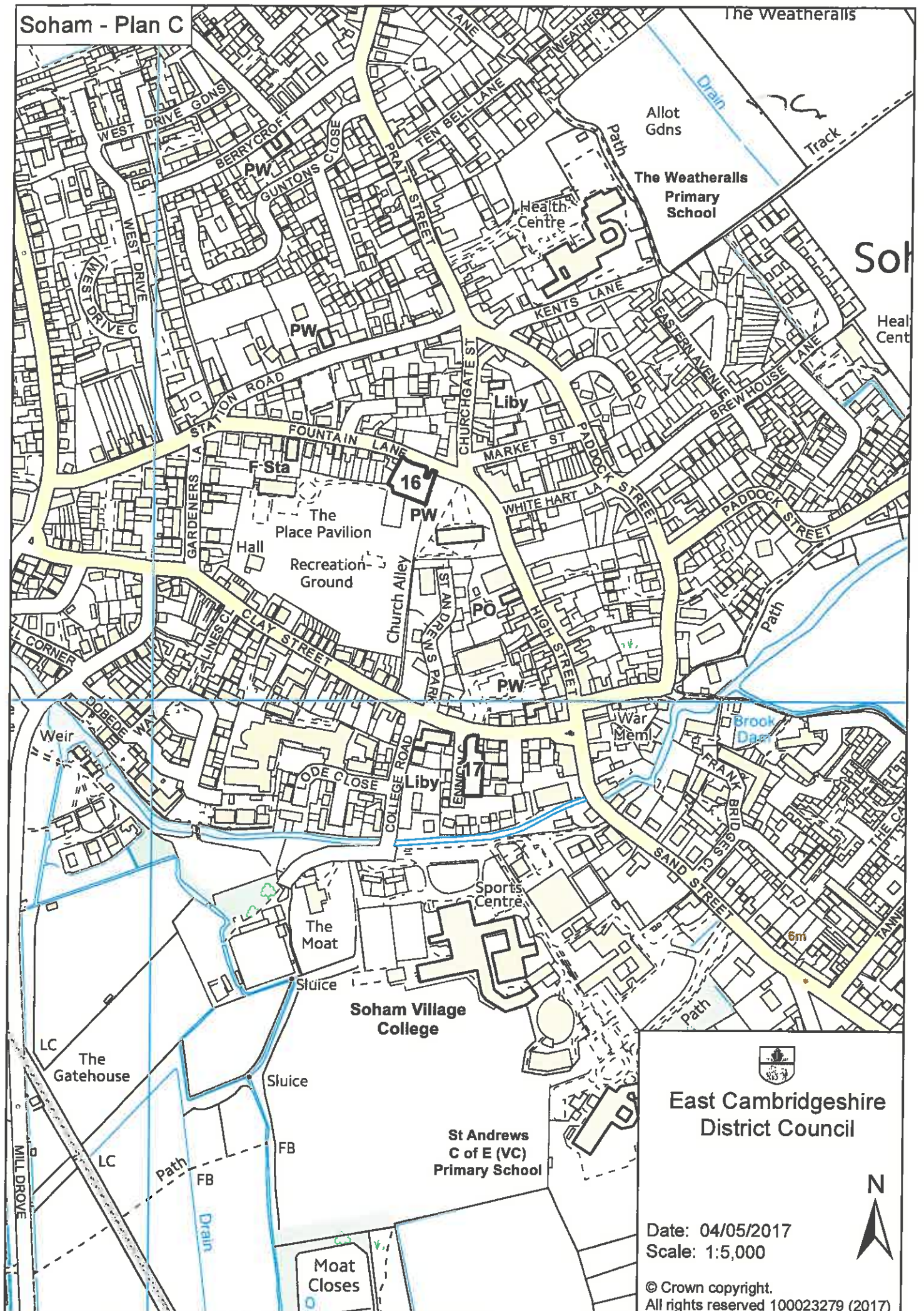
