Appendix 2 – Analysis of First Survey November 2019

Soham and Barway Neighbourhood Plan Stage 1 Analysis

Residents were asked the following questions:

- Y = Yes
- N = No
- There were 208 responses in total

The majority of residents who answered would like more family homes and no more homes for retired people. There were mixed views about the location of more housing, a very few thought they should be within the town centre.

91% of those who responded thought the town would benefit from increased employment opportunities.

The question asking for the most important issues regarding transport gave a very mixed picture. By a small margin, parking was the biggest issue, with frequency of buses and speeding traffic a close second.


The question about where you work produced similar scores for at home, Cambridge, Bury St Edmunds and other places. Fewer people work in London or Newmarket.

The question about which facilities the respondent and their family use in the town, clearly showed that dial-a-ride, allotments, teenage facilities, nurseries and childcare facilities were the least used.

The most frequently used (daily and weekly) facilities are the local shops, local footpaths, the post office and the commons.


The most popular facilities used monthly or occasionally were the doctors' surgery, the chemist, restaurants and takeaways, recreation ground, library and hairdressers.

1. What sort of housing do you consider is needed in the town?




- The majority of residents who answered would like more family homes.

2. More housing might be needed? Where do you think would be most suitable?




• Residents held mixed views about where new developments should be built.

3. Do you think the local area needs more employment opportunities?




• A high proportion of residents agreed that the town would benefit from more employment opportunities.

4. What do you consider are the main transport issues within the local area?




- The majority of residents thought that parking was the greatest transport issue.

5. If you are employed, where do you work?




6. Which facilities does your household use within the local area and how often?

The deeper the colour, the more frequently the facility is used.




Breakdown of facility usage



Make sure that there is sufficient provision for water, sewerage and electricity to serve the town properly.

What about flood risk protection

Do people want gardens or just public open spaces? More allotments? More playing fields?

More employment and more community facilities in the town are essential to encourage more community spirit in the community.

Must make sure that as much energy is saved by generation of electricity by whatever means – solar, wind and use of heat pumps, grey water, insulation and conservation. All homes <u>and</u> employment buildings should be made to provide whatever they can to manufacture their own electricity. Do not allow more solar panels on farm land using up precious open country.

Need to ensure for the sake of business that we have up-to-date telecommunications for phones and computers.

Provide suitable places where residents can enjoy the countryside b providing walks, cycleways and places suitable for dog walking – think about how we could open up the Lode through the town and Barway for leisure purposes – CIL contributions?

Appendix 6 – Village College Survey Results

Analysis of results of Village College Survey

221 students responded to the survey.

Summary

The results showed that just about half the students live in Soham. 59.7% of students are hoping to go to Bury ST Edmunds or Cambridge to study A levels, 10.9% want to do vocational qualifications or an apprenticeship at a local firm. 23% don't know what they want to do when they leave the college.

23.3% plan to work either in Cambridge or in the wider area of East Anglia. 15% want to leave the are and sadly only 1.8% plan to work in Soham. 52% do not know where they want to be.

Students were asked about the most popular form of transport. Not surprisingly, car came out as the favourite at 89% but walking came second at 79%. Bike and bus were more or less equal at around 35% and train only 14%. This may rise when the new Soham station has been open for longer.

The students were asked to list the 3 sports facilities is they would most like to have in the town. The most popular was a Multi-Use Games area with 49% and an outdoor gym area 48%, skateboard/bike ramp 45% and 4G Astro-turf pitch 43%. Various other suggestions included swimming pool, horse riding, outdoor trampolines and rock climbing wall.

Other facilities suggested were internet café 69%, teenage café 48%, volunteering opportunities 30% and an outdoor stage 29%. Other suggestions included a cinema and a Primark shop.

49% believe in protecting the environment but don't think about it much, 30% want to protect the environment and think about it a lot.

Sadly 5% don't think about the environment at all.

1. To help protect the environment, respondents asked to mark three best ideas. 68% suggested enhancing green spaces and extra outdoor activities 50.2% said to improve public transport, 47.1% wanted more and better bike paths, 33.5% want more events to educate young people about the environment, 25.3% want an environmental activities group. Interestingly it was suggested that that we need more bins and signs to encourage people to put rubbish in, and that more takeaways use more sustainable trays and forks.

Details

- 1. Almost equal numbers in each of the school houses
- 2. 49.3% live in Soham, 50.7% live in the surrounding area
- 3. 57.9% are intending to go on to either Bury St Edmunds or Cambridge to study A levels,

- 5.9% want to do vocational qualifications, 5% want an apprenticeship at a local firm, 23.1% don't know what they want to do. Others have listed all sorts of future routes including footballer, performing arts, horse riding, zoology, doctor.
- 4. 18.6% plan to work in Cambridge after post 16, 12.7% plan to work in East Anglia, 14.9% plan to leave the area, and only 1.8% plan to work in Soham. 52% have not decided yet.
- 5. Students were asked to list the 3 most used forms of transport.

 Cars came out on top with 89.6%, walking 79.8%, Bike and bus were almost equal with 35.7% and 35.3%, with train on 14.5%. This may well be substantially greater once the new train station in Soham is opened. (The station opened in December 2022)
- 6. Respondents asked to list the 3 Sports facilities which they would most like to see in Soham. The most popular were MUGA (Multi-use games area) on 49.3%, outdoor gym equipment gained 48.4%, skateboard park/bike ramp came in at 45.7% and 3G/4G Astro-turf pitch 43.9%. Other items mentioned were a swimming pool, horse riding area, outdoor trampolines/rock climbing wall and various other items.
- 7. Asked for 3 must wanted. 69.7% would use an internet café, 46.2% would like a teenage café, 30.8% listed volunteering opportunities (no detail as to what sort) and 29.9% wanted an outdoor stage. Other items included cinema, wooden huts to sit in, nicer social areas and a Primark shop.
- 8. 49.3% believe in protecting the environment but don't think about it much, 30.3% want to protect the environment and think about it a lot, 14.9% approve protecting environment but rarely think about it, 5.4% don't think about the environment at all.
- 9. To help protect the environment, respondents asked to mark three best ideas. 68.3% suggested enhancing green spaces and outdoor activities, 50.2% said to improve public transport, 47.1% wanted more and better bike paths, 33.5% want more events to educate young people about the environment, 25.3% want an environmental activities group. Some have suggested that we need more bins and signs to encourage people to put rubbish in, suggestion that more takeways use more sustainable trays and forks.

Appendix 8 – Analysis of business survey Summer 2021

Analysis of results business survey

19 responses

1. Where is your business located?

47% of respondents run a business in the town centre, 37% are based on a business or industrial park, 5% in the surrounding countryside, 11% say they are based somewhere else and no businesses from Barway responded.

2. Which of these best describes your business?

4 businesses said they were in retail, 3 are involved in leisure and 3 in manufacturing, 2 are in professional, financial or legal business and 1 in transport. 7 listed their business as 'other' which does not include agriculture, administration or warehousing.

3. Approximately how many employees do you have?

9 businesses have 1 to 5 employees, 4 have 6 to 10 employees, 3 businesses have 11 to 20 workers, 2 have 21 to 50, no businesses who replied had 51 to 100 employees and one business has over 100 employees.

- 4. How would you best describe your workforce in general terms?
 - 8 businesses use professional trained staff and 8 have skilled (trade qualified) staff. 5 businesses have semi skilled (NVQ or similar) staff, 2 employ unskilled labour (no qualifications) and one business has apprentices.
- 5. Approximately what percentage of your employees work these work patterns?

 None of the businesses run a day/night shift system. The majority of businesses
 52.6% have full time employees (7.5hours or more a day), 5.3% of the respondents
 employ all part time staff%. 10.5% have staff with variable shift patterns. In fact
 37.2% of the businesses employ part time staff who work less than 7.5 hours a day.
 Clearly part time work provides an important section of the jobs in Soham
- 6. What percentage of your workforce travel to work using these methods? 47.4% of businesses have 100% of employees who travel to work using a private vehicle. 36.9% also have between 10 and 50% of employees who travel by private car.
 - Only 5.3% have anyone who travels by train (the new train station had only just opened when this survey was done) 15.8% of businesses have staff who travel to work by bus. Up to 15.8% of businesses whose employees sometimes travel by works vehicle, obviously only when these are available. 15.8% have staff who work from home either all the time or for shorter periods.
- 7. What are the main reasons for having your business in Soham parish?

 9 businesses say that access to customers/suppliers and markets are important to their business in Soham. 8 businesses have local connections or are native to the area, and 8 appreciate the availability if suitable business premises. 3 firms say that access to national road network is important and single businesses noted individually

that suitable local housing, local transport system and availability of suitably trained staff were important.

- **8.** Do you plan to move or expand your business in the next 5 years?

 58% of businesses said they have no intention of moving in the next 5 years. 21% said they may consider moving and 21% are considering moving in next 5 years.
- 9. Please give reasons for your previous answer

Answers vary between 'business is doing well' and 'may need to find bigger premises'. Some are happy to stay local and some are looking for more trained staff.

- **10.** If you are planning to move, is it important to stay in the parish? 41% said no, 35% said yes and the rest were unsure and voted maybe.
- 11. Please give reasons for your previous answer

Many of these businesses have local connections or local customers. Some are happy to be here because they have good road links.

- 12. What sort of business premises do you think are most needed in the parish?

 Because of the small number of respondents it is hard to see clearly what sort of premises are most needed. However, it is clear that several businesses see the need for more large retail and office space. There does not seem to be much appetite for small premises either for offices, retail or warehousing.
- 13. Thinking about the local internet and infrastructure please tick all the options which are important to businesses in Soham parish.

The local internet and local road infrastructure are clearly of great significance for local businesses (17 and 16 votes each). The new Soham railway station (10 votes) and availability of suitable business premises (8 votes) were significant but interestingly only 5 businesses mentioned the skill level of prospective employees.

- 14. What do you think is the single most important thing which can be done to encourage more people to live <u>and work</u> in Soham?
 - Several businesses mention that we need bett5er infrastructure and in particular better public transport and road network. Improving local facilities and tidying up the town would also bring more tourism etc
- 15. What is the single most important thing which can be done to encourage more young people to work in Soham parish?

Respondents think we need more businesses which provide more varied jobs including apprenticeships, in particular retail because they give young people the chance of a part time job as a try out. Get education to provide the type of training for young people needed eg. Not just computers but manual stuff too.

- 16. What do you think would be most effective in reducing the use of private vehicles for commuting to work?
 - Many respondents mention the need for better more efficient, cheap local buses which provide links not just to Ely and Newmarket but also the surrounding villages like Isleham and Wicken. Also improve and add to cycleways and provide better lighting. Provide better link to train station and network of electric vehicles.

From this it is clear that many businesses value their location in Soham because it provides what they need.

When asked if they had to move, would they want to stay in Soham, 35% said yes and 24% said maybe. There were various comments about why they wanted to stay or leave. One said the lease was too expensive and another that there was a lack of skilled workers. Some say that they have the premises they need and their customers are here.

Businesses were asked what would sort of premises are most needed in the parish. Larger retail and manufacturing/warehouse premises seem to be most needed with small start-up premises also popular.

Businesses were asked which of the alternatives are most important to local business. The results make clear that transport networks and the internet are the most important.

When asked what would encourage more people to live and work in Soham, there was a large number of comments about transport links again - buses, trains and the need for them to run on time. Other things mentioned were the need for good quality housing and local places to relax.

Respondents were asked what would make more young people stay and work in Soham. The replies were very varied but include an emphasis on larger businesses with more flexible employment opportunities, apprenticeships for young people, more training suitable for the jobs available locally.

When asked about the single most important thing which would improve the reduction in the use of cars, it was very clear that local transport needs an overhaul. There needs to be more, better, faster, cheaper transport and good links between the different types enabling people to travel more easily between local places. One respondent pointed out that better internet connections would make it easier for people to work from home if they wished to.

General comments provided a chance to mention the cost of housing in the area. There is very little affordable housing that young people can afford either to buy or rent. It was also pointed out that the retail offer in the High Street will probably reduce even further because the rents asked are much too high and the rates for businesses need revision too.



Appendix 10 – Analysis of Green Spaces Survey

Analysis of Green Spaces survey

119 people responded

1. Over the last 12 months approximately how often have you walked or cycled on any of the green lanes, lodeside walks, open green spaces, footpaths or cycleways in the parish of Soham?

12 people said they never use any of these green spaces. 41 people use these spaces daily and 27 say they use them 2-3 times a week. 51 use them between once a week and once a month.

2. Which three of these were most important to you during the lockdowns?

82 people put open spaces as being most important to them, 78 said footpaths were important,36 people listed cycleways as important, green lanes had 34 votes and Lodeside walks got 32 votes.

3. Thinking about other types of green spaces - playing fields, children's playgrounds, allotments, recreation ground and gardens next to your home. On average, over the last 12 months, how often do you make use of these areas?

64.3% said they were using gardens (private or communal) every day or 3-4 times a week. 21.6% people used the school playing fields every day or 2-3 times a week and public playing fields had much the same support 23.1%. 18.2% VOTED FOR THE Recreation Ground and 6.7% used children's playgrounds every day or 2-3 times a week. Allotments were used by 7.2% only.

4. Which of these areas was most important to you during the lockdowns?

59.5% chose a garden next to home as the most important to them. 6.9% chose playing fields. The Recreation Ground came next with 31.9% choosing this as most important while childen's play areas and allotments scored only 0.9% as first choice but the play areas scored better for 2nd choice 6.9%.

5. What do you think could be done to improve these areas most?

The highest scorer was to provide more dog litter bins 27 people wanted this and 25 wanted better surfaces on paths. 19 people want more information about wildlife (and historical info too). 13 want easier access and 3 mentioned places where you could meet up with friends.

6. Which of these areas have you heard of or visited?

Qua Fen Common is the most popular with 84 people saying they have visited or know about it. Interestingly Front and back Angle Commons and back East Fen Common have a similar number of votes (49, 47 and 44 respectively). Front East Fen Common and North Horse Fen have identical scores (39 each) while South horse Fen and Broadpiece have smaller scores (33 and 34 respectively). The SSSI Wet Horse Fen, has the lowest score at 27 (perhaps a blessing for the wildlife). 29 people said they have never visited or heard of any of the areas listed.

7. Which of these areas have you actually visited in the last 12 months.

Qua Fen Common remains the highest scorer with 69 people saying they have visited in the last 12 months. The other results mirror those from the previous question with all results lower that before except for those 37 that say they have never visited any of the areas.

8. How often during the last 12 months have you visited any of these areas?

19.1% say they have visited Qua Fen Common daily or 2-3 times a week. Broadpiece, Front and Back Angle Common are all similar at about 10% daily or 2-3 times a week.

The remainder have visitors daily or 2-3 times a week around 7-10% but the least visited is Wet Horse Fen (SSSI) at only 5%.

9. Why do you like visiting these commons areas?

The post popular reason is for exercise (walking or cycling) and scored 72. The next two most popular were dog walking (51) and to enjoy the wildlife (51). 46 people visit to relieve stress and unwind. 14 like to take photos of the wildlife and 8 to entertain the children. 16 people listed 'other' but few gave reasons — one mentioned not feeling safe there because it is a long way away.

10. Many of these green spaces are gradually losing much of their natural wildlife and plants. How do you feel about this?

4% people said they were not bothered, and 15% sad it was a pity. 45% said we need to stop the losses and 36% want to act fast to prevent any further losses.

11. What do you think is the most important thing to do to improve our green spaces?

The free form answers were very varied but many mentioned preventing any development, reducing how much litter is left and trying to improve the biodiversity by introducing more plant species so they look more attractive.

12. Are there any other places around the parish which you think should be protected from development? Please try to explain briefly where and give reasons why you think they need protection.

Many different areas and reasons in the 66 responses. But it is clear that people see Soham has had enough development and they are concerned about further losses of green spaces. People also want to see connections between the green spaces so that wildlife can move about safely. Should not be altering the balance between development and green (natural) space for either the wildlife or the people living there.

13. Would you be interested in helping to improve

our green spaces if needed?

16% said no, 23% said yes they would help and 60% said maybe they would help.(it probably depends on what and when they were asked to do something!)

Commentary on the Green Space Responses

Initially we needed to find out how much the local community knew about the open spaces and walks etc around the town and how much they used them. This survey particularly applied to their use during lockdown because it had been very apparent that the local population had made very good use of these areas for recreation.

47 respondents said they used them daily and 21 used them weekly. It seems from this question that there is a split in the community in that two thirds use these spaces regularly and the rest either not at all or very irregularly. The next question asked how important these places were during lockdown.



Green lanes and open spaces are clearly very popular.

The next question asked about the use of 'managed' green spaces i.e. recreation ground, school playing fields, public playing fields, allotments, children's play areas, private or communal gardens.

Interestingly the most used area was private or communal gardens next to the home which were used daily or twice weekly by 63% of respondents. Playing fields were also used quite a lot but children's play areas were not (probably because of fear of infection) and nor were allotments.


Private and communal gardens also showed their importance as 59% chose them as their most import with a further 26% rated it as it as second choice. The next most important was the recreation ground at first choice 32% of respondents.

A question about what would improve these areas proved interesting. The most popular suggestion was to have better surfaces on paths and the second was to have more dog bins provided. Also provision of information boards about what could be seen was supported by 19 people.

The survey provided a map showing all the commons and horse fens in the area. Respondents were asked which of these they had heard of or visited.

Qua Fen Common was by far the best known with 84 people mentioning it. The next most well known is front Angle common.29 respondents said they had never heard of or visited any of these places.

The next question asked how many of these places they had visited in the last 12 months. Once again Qua Fen Common is the best well known and most visited. Interestingly the Wet Horse Fen SSSI is less well known and less visited than any other areas. Perhaps that is a benefit to the local wildlife!



When asked why respondents visited these areas it is clear that exercise was by far the most important reason because 72 replies listed this. Walking the dog and enjoying the wildlife came in second with 51 votes. Relieving stress and unwinding came close with 46 votes.

The survey explained that many of these green spaces are deteriorating and asked how the respondent feels about this.

Figure below clearly illustrates how local people feel about this. 91% of respondents are aware of this and anxious about the need to do something.



Question 11 asks for suggestions as to how best to improve our green spaces there were a lot of valid comments. These fell into various categories

- Stop building on commons and open spaces and restrict the amount of building adjacent to these areas
- Educate the community about the value of these areas for people, wildlife and climate change perhaps by running guided walks, going into schools and with information boards
- Plant more trees and other wild plants beneficial to insects and other animals
- Discourage people from leaving litter more litter bins and dog bins
- Consider designating areas specifically to protect wildlife.
- Better conservation management and encouraging nearby farmers to be involved.

Question 12 ask for respondents to note other areas that need protection. It is clear, reading through the comments, many people really value the green spaces in the town and are very disturbed at the amount of housing which is reducing the green spaces and farmland precious to the town. It is particularly interesting that the Lodeside walks and other waterways and ponds are mentioned as needing particular protection and that people should be encouraged to stop dropping litter everywhere.

When asked if they would be prepared to help with improving these spaces, only 18% said no, 60% said maybe, 26% said yes.

This survey has demonstrated very clearly that local people really value the open spaces, countryside walks and wildlife that surrounds them in Soham and are keen to ensure that no further green spaces are lost to them or to local wildlife.
