WHAT ARE WE DOING?

Not only will a maze help the environment, it will also provide you with a new and exciting challenge!

WHY TREES FOR A NEW MAZE?

Because trees are amazing! They are home to 1000s of animals, from tiny insects to nesting birds. They help keep you cool in the summer and dry in the rain, plus they breathe out oxygen, which keeps you healthy and also helps ensure the planet doesn't overheat!

WHAT WE WANT YOU TO DO!

We want you to design the maze!

Whoever comes up with the best design for our new maze will get it planted at Ely Country Park.

Can you imagine seeing people trying to solve your planted design everyday of the week?!

HOW MANY MAZES ARE BEING PLANTED OUT?

Two!

We want to do one larger maze, plus a smaller one next to it with a lower hedge cut aimed more at younger children.

You can enter your designs for just one or both mazes. Good luck!

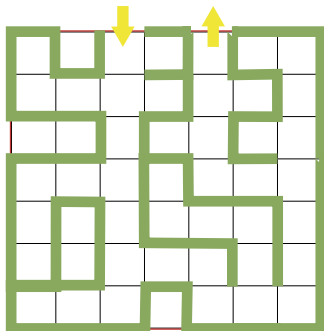
WHEN WILL IT OPEN?

We hope to open it in Spring 2022.

HOW MANY TREES?

Up to 5,000 will be needed!

EXAMPLE MAZE



To complete the template, use a large felt tip or marker pen to draw over the lines in the grid.

Where you mark will be where we plant the trees!

THE RULES

1. The maze has to be designed using the template provided. This will make sure that we have sufficient space to plant your design.
2. The maze needs to be designed using straight lines – no curves or bends please!
3. The entrance and exit to the maze are given on the template. Please don't change the location of these.
4. The competition is open from now until 12:00 on Wednesday 29th September.
5. All designs should be submitted to the Council at the following address:
The Grange, Nutholt Lane, Ely CB7 4EE (your school or other club may wish to collect designs and send them all to the Council in one go – please check with your local school or club)
6. The competition only open to those aged 18 or under.
7. The winners will be announced on Friday 1st October and we will aim to start planting the maze before Christmas this year!

TOP TIPS

Please use the template to make your entries.

Perhaps you could include a central area for someone in the maze to reach?

Or, perhaps you could create a few 'stops' you have to go through before completing the maze? Maybe you could collect a stamp, or find a clue at each stop?

WHAT SORT OF TREES?

We are going to use hornbeam trees to create the maze. This is because they are a safe tree to use, keep their shape well (even in winter) and are native to this country.

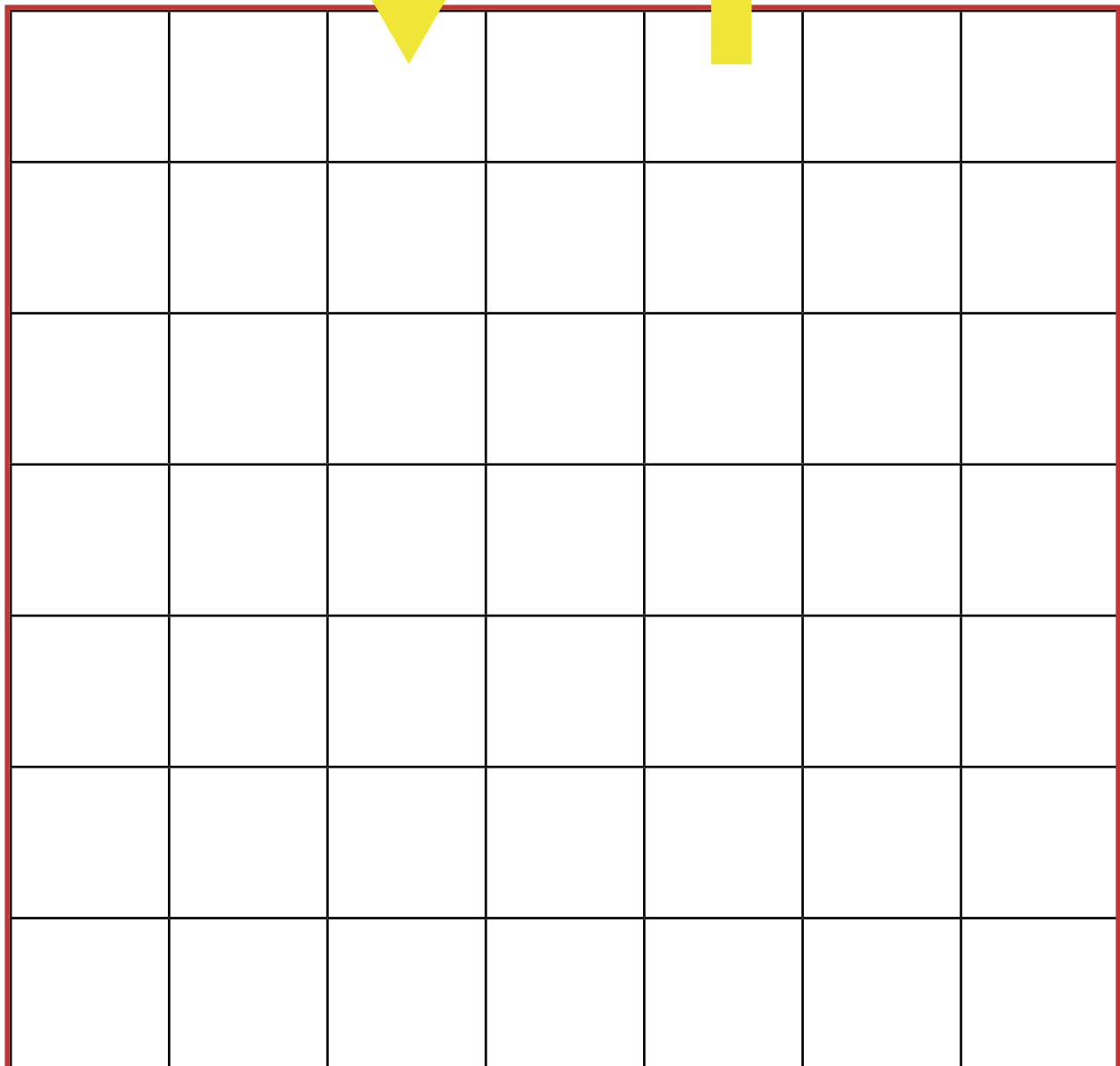

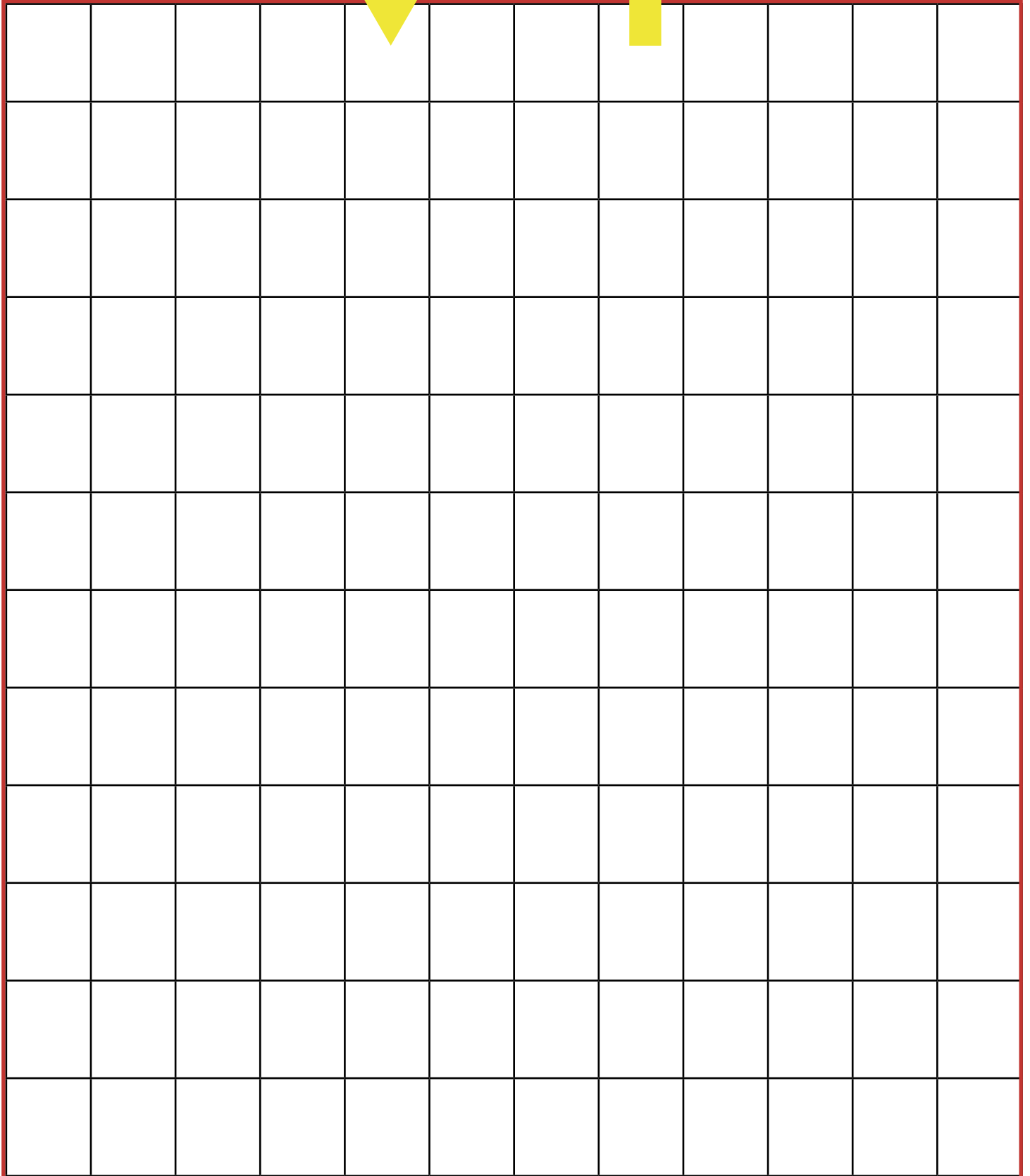

TERMS AND CONDITIONS FOR THE 'REAL TREE MAZE' COMPETITION

3. The Maze must be designed using the template provided on the 'BE A-MAZE-ING' Leaflet.
4. The Maze needs to be designed using straight lines only, curves or bends will not be accepted.
5. The entrance and exit to the Maze are as shown on the template provided on the 'BE A-MAZE-ING' Leaflet, the location of the entrance and exit cannot be changed.
6. The competition is open from now and ends at 12:00pm on Wednesday 29th September 2021.
7. All designs should be submitted to East Cambridgeshire District Council at The Grange, Nutholt Lane, Ely CB7 4EE or emailed to: climatechange@eastcambs.gov.uk
8. Please note that entries will not be returned, therefore, make a copy if you wish to retain a copy.
9. The Winners will be announced by East Cambridgeshire District Council on Friday 1st October 2021.
10. The Winners will be contacted by East Cambridgeshire District Council and confirmation of the Winner's name and age will be published by East Cambridgeshire District Council in post-competition publicity. By submitting an entry, the applicant accepts that their name and age will be published in post-competition publicity.
11. East Cambridgeshire District Council's decision is final and no correspondence will be entered into. The organisation and judging of this competition is controlled by East Cambridgeshire District Council and the decision of Richard Kay is final in every situation including any not covered above and no correspondence will be entered into.
