Each candidate standing on the 2 May 2024 PCC elections is entitled to have an election address published on www.choosemypcc.org.uk website.

This letter sets out the timetable and process for the submission of candidates' election addresses.

Requirements of an Election Address

Timetable for the submission of the Election Addresses

All election addresses must be submitted by Friday 5 April 2024 by 12 noon.

**THIS DEADLINE IS THE LAST POSSIBLE DATE FOR THE SUBMISSION OF
CANDIDATES' ADDRESSES, WHICH WILL NEED TO BE FULLY COMPLIANT.**

**YOU ARE STRONGLY ENCOURAGED TO SUBMIT INITIAL DRAFTS WELL IN ADVANCE
OF THE DEADLINE. THE PARO CAN GIVE INFORMAL FEEDBACK FROM 18 March
2024.**

The date and time of the submission of candidates' addresses will be published by formal notice.

Election addresses must be prepared on the template supplied by the PARO. For 2024 elections, for this purpose, election agents will be directed to the CMPCC uploader will 'go-

live' to enable agents to input election statements on MONDAY 18 MARCH 2024. You will receive a log-in from the PARO on this date. More details to follow very shortly.

To outline the timetable in more detail, specifically:

Submission of election addresses to PARO for informal checking against legislative requirements – from 18 March 2024.

PARO to inform candidates/agents of formal acceptance of their election address – from 26 March 2024 to 5 April 2024.

Election addresses published on website (www.choosemypcc.org.uk) 10 April 2024.
