## **REGISTER OF MEMBERS' INTERESTS**

### **THE RELEVANT AUTHORITIES (DISCLOSABLE PECUNIARY INTERESTS) REGULATIONS 2012**

#### **Explanatory Notes**

1. This form must be completed and returned within 28 days of the adoption of the Code of Conduct or within 28 days of your election or appointment to office.
2. You must within 28 days of becoming aware of any changes to the interests specified above provide written notification to the Monitoring Officer of that change.
3. The Register of Interests is maintained by the Monitoring Officer in accordance with Section 29 of the Localism Act 2011 and will be published on the Council's website.
4. If you have a disclosable pecuniary interest and you consider that disclosure of that interest could lead to you or any person connected with you, being subject to violence or intimidation, you may apply to the Council's Monitoring Officer to exclude details of the interest from the published register, (but it may state that the Member has an interest, the details of which are being withheld).
5. In certain circumstances, failure to register or to declare a "declarable pecuniary interest" is a criminal offence. So is speaking and voting, unless you have a dispensation. This is punishable on conviction by a fine of up to £5,000 and/or disqualification as a councillor for up to five years.

**3. Contracts**

Any contract made between the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners (or a firm in which such person is a partner, or an incorporated body of which such person is a director<sup>3</sup> or a body that such person has a beneficial interest in the securities<sup>4</sup> of) and the council -

- (a) under which goods or services are to be provided or works are to be executed; and
- (b) which has not been fully discharged.

**4. Land and Property**

Any beneficial interest in land which is within the area of the council. Land excludes an easement, servitude, interest or right in or over land which does not give the councillor or his/her spouse or civil partner or the person with whom the councillor is living as if there were spouses/civil partners (alone or jointly with another) a right to occupy or to receive income.

  - (ii) if the share capital of that body is of more than one class, the total nominal value<sup>5</sup> of the shares of any one class in which the councillor, or his/her spouse or civil partner or the person with whom the councillor is living as if they were spouses/civil partners has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

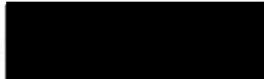

- <sup>1</sup> **'Member'** includes a co-opted Member.
- <sup>2</sup> **'Partner'** includes your spouse, civil partner or person with whom you are living as if they were your spouse or civil partner.
- <sup>3</sup> **'Director'** includes a member of the committee of management or an industrial and provident society.
- <sup>4</sup> **'Securities'** means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
- <sup>5</sup> **'Nominal Value'** means the amount shown on the share certificate, not the market value.
