undertaken and firmly believe that this is still required and this is further strengthened by the Inspector's findings in the appeal at Broad, Piece, Soham APP/V0510/W/21/3282449 which found that:

"The past shortfalls in delivery against the plan requirement are indicative that the allocations are not meeting housing needs and may be insufficient."

Without a whole plan review and full understanding of why delivery in the district is slow, the housing requirement is not going to be met, therefore updating the housing requirement only as proposed by this Single Issue Review of Policy GROWTH 1 is not addressing the issue of under-delivery; for this reason the Review is unsound as it not effective to take one policy in isolation when other policies have also been found to be out of date as part of appeal APP/V0510/W/21/3282449, these being policies GROWTH 2 and GROWTH 4. In examining whether policy GROWTH 2 is out of date the Inspector finds that:

"Whilst there is no dispute that for the purposes of calculating housing land supply, the standard method should now be used and that this seeks to address past shortfalls, that does not make the hefty shortfalls against the ECLP requirement immaterial. It is, in my view, an important indication that the ECLP has not been effective in meeting housing needs since the beginning of the plan period and casts further doubt as to whether the Council's locational strategy can be relied upon to significantly boost housing delivery in line with the National Planning Policy Framework (the Framework)."

This demonstrates that whilst the Inspector agrees that the standard method should now be used and therefore
