If a zoo operator is aggrieved by a decision made by East Cambridgeshire District Council to refuse to transfer a zoo licence a person can apply to the Magistrates' Court within 28 days of receiving notice from the Local Authority. Magistrates can confirm, vary or reverse the Council decision.
