### 1.0 ISSUE

1.1 To consider the recommendations from the Growth and Infrastructure Fund Scoring Panel.

## 2.0 RECOMMENDATION(S)

- 2.1 Members are requested to:
  - i) Increase the Growth and Infrastructure Fund from the allocated £2,000,000 to up to £2,307,216
  - ii) Approve the funding of the following projects:
    - a) £250,000 to National Trust- Wicken Fen Burwell Lode Crossing
    - b) £124,056.00 to Viva Arts and Community Group- Apprenticeship, Traineeship & Learning Hub with Solar
    - c) £800,000 to Soham Town Council- Soham to Wicken Cycleway
    - d) £700,000 to Stretham Parish Council- Stretham Community Hub
    - e) £191,535 to Witchford Playing Fields Association- Village Hall Expansion Project
    - f) £105,000 to Bottisham Parish Council- Bottisham New Cemetery
    - g) £51,360 to Soham Town Rangers Football and Social Club- Community Club Refurbishment
    - h) £22,265 to Isleham Community Association- Commercial Kitchen
    - i) £63,000 to Little Thetford Village Hall- Moving to an all-electric village hall using renewable energy
  - iii) Delegate authority to the Director Community, in consultation with the Chairman of Finance & Assets Committee, to complete funding agreements for the funding and projects identified in 2.1 ii) a-i) which will contain the conditions set out in 4.4 of this report.

#### 3.0 BACKGROUND/OPTIONS

3.1 The Growth and Infrastructure Fund Scoring Panel was established by Finance & Assets Committee on 23 June 2022 to score applications for the £2M Growth and Infrastructure Fund against the criteria approved by the parent Committee

- and to make recommendations for approval of grant funding back to the meeting of the Committee on 24 November 2022.
- 3.2 The Panel met via Zoom on two occasions on 27 October and 1 November 2022, a summary of these meetings can be found at Appendix 1.

### 4.0 ARGUMENTS/CONCLUSIONS

- 4.1 14 applications were received, 1 was submitted after the closing date and 4 did not meet the Cambridgeshire Horizons objectives. The remaining 9 eligible applications were scored by the Panel using the criteria approved by this Committee.
- 4.2 A summary of each application, details of the score awarded by the Panel and the amount of Growth and Infrastructure funding requested can be found at Appendix 2.
- 4.3 The Panel noted the high quality and community 'worthiness' of all of the projects and the fact that, if the £2M funding threshold was adhered to, potentially some projects might not receive a funding allocation.
- 4.4 The Panel therefore recommended that Finance and Assets Committee be requested to increase the Growth and Infrastructure Fund budget, to enable all of the 9 eligible applications to be funded, subject to confirmation of the sum requested by Isleham Community Association, and the following conditions for the payment of any funding awarded:

## Evidence being provided that:

- All necessary permissions are in place
- Match-funding is secured
- Funding is only utilised for Capital elements
- Payment be made on receipt of invoices

# 5.0 <u>FINANCIAL IMPLICATIONS/EQUALITY IMPACT ASSESSMENT/CARBON</u> IMPACT ASSESSMENT

- 5.1 There is sufficient Cambridgeshire Horizons money remaining to allow for the proposed increase in funding.
- 5.2 Equality Impact Assessment (EIA) not required.
- 5.3 Carbon Impact Assessment (CIA). Directly, the provision of funding would have no direct carbon implications on ECDC operations.
