## 1.0 <u>ISSUE</u>

1.1 To receive proposals for the Burwell Masterplan issues stage public consultation.

## 2.0 <u>RECOMMENDATIONS</u>

Members of the Working Party are requested to:

- a) Make comments on the draft Burwell Masterplan Issues Stage Community Questionnaire
- b) Recommend the draft community questionnaire for public consultation purposes, subject to any amendments agreed under (a) above.
- c) Approve the consultation approaches being proposed for the public consultation work.

d) Advise whether the working party should invite representatives of any of the key stakeholder organizations to a future meeting to discuss any particular issues in more depth.

## 3.0 BACKGROUND

3.1 The Burwell Masterplan Consultation Strategy was adopted at the Working Party meeting held on 28<sup>th</sup> July 2011. It proposes a number of activities during the two week issues stage consultation to run from 19<sup>th</sup> September – 30<sup>th</sup> September 2011.

## 4.0 PROPOSED CONSULTATION ACTIVITY

4.1 Community Questionnaire – A community questionnaire, to obtain local peoples views on the issues they think the Burwell Masterplan should consider, will be printed in the Burwell Bulletin on 17<sup>th</sup> September 2011. The Bulletin is delivered to every household in the village, giving everyone an opportunity to have their say. Collection of questionnaires could be via local champions or collection boxes could be located around the village.

- 4.2 A copy of the draft community questionnaire is attached for comments.
- 4.3 Burwell Masterplan Drop-in Event Following requests for a public event from those present at the last Working Party meeting, it is proposed that a drop-in event be held at the Gardiner Memorial Hall on either Saturday 24<sup>th</sup> September or Saturday 1<sup>st</sup> October 2011. The purpose of the event will be to allow local people to drop-in to ask questions and/or discuss any issues or concerns with officers and Members of the Working Party. It is anticipated there will be displays highlighting some of the findings from the desk research and maps for people to write their ideas/comments on. The advantage of a drop-in over a focus group is that it will allow more people to participate, but still capture views about issues that the research may not have identified to date. Members of the working party are asked to reserve the dates in their diaries.
- 4.4 Unmanned Displays It is proposed that Officers contact a number of local shops and public buildings to ask them to host a display promoting the Masterplan process, the questionnaire and the drop-in event, to increase awareness of the consultation.
- 4.5 Stakeholder Meetings Officers are planning to meet with representatives from Cambridgeshire County Council, The National Trust, Forest Heath District Council, The Highways Authority, Anglian Water and other organisations during the consultation period to ascertain their views on Burwell and any plans for future development/improvements in the village. The working party is also asked to consider whether they wish representatives of any of these stakeholders to be asked to come to a future meeting to discuss issues in more depth.
- 4.6 Young People Consultation with young people in Burwell, working with the County Council Youth Development Co-ordinator, is also planned to take place when the new school year starts.
- 4.7 Press and PR To publicise and raise awareness of both the questionnaire and the drop-in event to maximise participation, posters will be put up around the village and press releases submitted to the local newspapers.

## 5.0 FINANCIAL IMPLICATIONS/EQUALITY IMPACT ASSESSMENT

- 5.1 Room hire and printing costs will be met from existing budgets.
- 5.2 An Equality Impact Assessment (INRA) will need to be carried out on the final Burwell Masterplan document.
