1.0 <u>ISSUE</u>

1.1 To consider a grant application from Fordham Community Land Trust.

2.0 <u>RECOMMENDATION(S)</u>

2.1 Members are requested to approve the £5,000 grant application to benefit Fordham Community Land Trust.

3.0 BACKGROUND

- 3.1 On 25 September 2014 Corporate Governance and Finance Committee recommended a one year extension of the community land trusts programme to Full Council in February 2015. The programme was agreed, which includes a £10,000 provision for community land trust set-up grants. Witchford Community Land Trust and Haddenham Community Land Trust have been successful in their grant applications.
- 3.2 Fordham Community Land Trust has requested £5,000 to fund public meetings (hire of hall, printing of leaflets), pay for legal advice, purchase of model set of rules, registration with the FCA and assistance to prepare a constitution.
- 3.3 This application for a grant would be in addition to the £10,000 already approved for Witchford Community Land Trust and Haddenham Community Land Trust. This £5,000 grant can be met from current underspends in the Infrastructure & Strategic Housing budget.
- 3.4 The full application from Fordham Community Land Trust is provided at Appendix 1.

4.0 ARGUMENTS/CONCLUSIONS

- 4.1 The application has been assessed by the Council's CLT Advisor who confirms that the key information required by the applicant has been included, specifically:
 - Vision for the organisation and initial views on the appropriate legal model
