## 1. East Cambridgeshire Community Safety Partnership Vision Statement 2016-2019

#### Introduction

This Vision is intended to give an overview to partners and members of the public regarding the overall direction that East Cambs CSP will be taking over the next 3-years, and to outline aims & objectives. Details of how we intend to achieve these goals/aims can be found in the Community Safety Partnership Action Plan. The Action Plan is refreshed annually, but also has a dedicated officer group who can respond to emerging crime trends & issues throughout the year.

The CSP webpage also has links to further information about our services.

Whilst we have avoided the use of 'jargon' in this document, by necessity we have made references to community groups, organizations and legislative processes that you may not be familiar with. With this in mind we have provided a glossary of terms & definitions at the back of this strategy. Therefore whenever you see an underlined word in the main body of the text (excluding heading titles) this indicates that a more detailed explanation is available. However the strategy has been written in such a way that it can be read as a standalone document.

## **Priorities and aims**

Our mission statement

Under the Crime and Disorder Act provisions East Cambridgeshire Community Safety Partnership will work to reduce threat, risk and harm to victims of crime and anti social behaviour.

We will achieve this by adopting the following Strategic Priorities;

## STRATEGIC PRIORITY 1. VULNERABILITY AND RISK:

Developing a framework for identifying the most vulnerable in our communities using robust data and intelligence to ensure that all agency frontline employees have baseline knowledge of identification, services available, safeguarding and referral pathways.

# **STRATEGIC PRIORITY 2. DIVERSION AND INTERVENTION**

Providing support to young people at risk of offending to prevent them becoming involved in anti social behavior and crime. We use a 'carrot and stick approach to ensure that positive behavior is rewarded and raise awareness that negative choices have consequences.

Young people are disproportionately affected by crime and ASB committed by other young people – as evidenced by young people being assaulted by others involved in ASB in Soham in recent months. We also recognise that young people can be vulnerable within relationships with their peers, and susceptible to pressure to become involved in inappropriate sexual activity. We will be looking to address this in 2016-17 through initiatives such as the "Chelsea's Choice" campaign.

# STRATEGIC PRIORITY 3. COMMUNITY COHESION AND ENGAGEMENT

As a collective of statutory bodies and interested parties, the CSP has a crucial role to play in improving community cohesion, as we are able to influence crime rates, people's perceptions of feeling safe, being satisfied with local services and being able to participate and influence local decisions, all of which are positive indicators for community cohesion. Engagement with our local communities is equally as important and is a fundamental part of cohesion activity, it is the means by which we interact with our service users, enabling us to gauge tensions from the community intelligence we obtain through interaction, thus prioritizing resource deployment and further engagement activity, and enabling our communities to influence our service delivery, and shape our policies and practices. Our focus will be on improving our engagement with all communities particularly seldom heard communities and devising and delivering bespoke projects on promoting community cohesion across the District.

## We will use the following means to help us deliver the Strategic Priorities;

**STRUCTURE AND MEMBERSHIP**: Ensuring that the CSP has an effective structure and membership that is fit for purpose and can develop and ensure the delivery of the strategy.

**INTERVENTIONS:** Delivering coordinated services to reduce the threat, risk and harm associated with anti social behaviour and acquisitive crime as it affects vulnerable adults.

**DATA AND INTELLIGENCE / TARGETING**: increasing understanding of context and prevalence of issues through ongoing robust data gathering to a common standard by all partner agencies. Increasing awareness and reporting of issues and incidents affecting the most vulnerable and those at risk of offending

**RESOURCING:** A Three Year funding package between partners in place to support Project Interventions.

**VOLUNTEERING:** Building capacity and competence within communities to deliver community safety benefits.

**CAMPAIGNS:** On Key issues to raise awareness within local communities


**BUSINESS PLANNING:** We will use budget and project management to deliver our priorities in an efficient manner.

#### **Ownership and delivery**

The implementation of this strategy will be the responsibility of the multi agency Project Team. Delivery will be via their Bi Monthly meeting with associated 'task and finish' groups for each of the strategic areas.

This strategy is supported by annually refreshed action plan that sets out objectives, accountability and milestones for implementation.

The following diagram shows the reporting structure for the groups and alignment with other partnerships.



## Meeting emerging challenges – a Three Year forecast

#### To be developed under further work but to include element such as;

- Key developments in the District and their forecast impact on service demand (include North Ely development and Soham developments). Include reference to new communities initiative from Cambridgeshire County Council lead by Director Anita Howard.
- Demographic changes in the district including population age and income.
- Emerging changes due to Welfare reform and Universal Credit
- General broad brush forecasts of crime and disorder impacts arising from demographic and development changes
- Major forthcoming legislative changes in crime and disorder
- Where might the CSP need to focus its attention either geographically or logistically?

## Three Year resource commitment 2016 – 2019 (towards a Three Year Package)

#### Cambridgeshire Constabulary:

- Will lead the monthly RIK group meeting and lead on enforcement work on designated individual offenders
- Will lead on most cases of ASB involving individual offenders and involving issuing of CBO/CI.
- Will lead on Crime and Disorder data provision to meetings
- Will lead on Reviewing and adopting Strategic Assessment reports commissioned through the District Council/County Council SLA
- Will lead on gathering evidence base for interventions under the ASB Crime and Policing Act including PSPO and CPN.

#### East Cambridgeshire District Council:

- Will commit a portion of its Community Safety Budget towards Project work in the Rolling Plan
- Will lead on consultation and eventual implementation for PSPO or issue of CPN.
- Will formulate a strategy between partner agencies (including all RSL's) for referrals to the Mediation service involving neighbour disputes that are difficult to resolve by enforcement and ASB legislation. The Strategy will look at a joined up response to risk and deployment of resources including officer time and procurement of specialist mediation services.
- Will monitor noise nuisance complaints between neighbours referred to environmental health services.
- Will handle reports and interventions (including fixed penalty notices) to enforce against dog fouling, fly tipping, abandoned vehicles, littering, presentation of waste, cleansing, illegal (unauthorised encampments).
- Will lead a Partnership shared approach to securing Strategic Assessment reports with Cambridgeshire County Council Research Team. To include looking at options for shared budget between agencies to resource the reports.
- Will hold in reserves a £6K budget to assist delivery of one occasion of Domestic Homicide Review (DHR)
- Will support the CSP through core administrative functions including;
  - > CSP Board meetings arranging and agendas, invitations, minutes, action records
  - CSP RIK Group minutes, action records
  - > Providing 1:1 support to the CSP Chair on current issues, governance, budgets,
  - > General Partnership administration maintaining all records, reports, files.
  - > Action Plan development and Project monitoring / Quarterly Performance reporting

#### **Sanctuary Housing:**

- Will provide an annual contribution to the CSP Pooled Fund in support of Project Delivery in the Rolling Plan
- Will support data requests for joined up working and mutual benefits to its tenants and the wider community
- Will provide a Community Fund for use on designated projects within the District

#### Cambridgeshire Fire and Rescue:

- Will lead on the Safety Zone annual initiative involving year 5 pupils from across the District
- Will lead with the Police on the Vulnerability and Risk Priority
- Will monitor reports of deliberate fire setting and associated offenders and sharing data on such with other Partners to this agreement.

- Will actively work with other Partners to this agreement to develop wording on interventions where an individual has been involved in deliberate fire setting as one amongst a range of anti social behaviours.
- Will populate ECINS with such data on individuals and locations as is deemed necessary to check and prevent any future cases of deliberate fire setting.

# Cambridgeshire County Council:

## Research Group:

- Will lead on producing the Quarterly Strategic Assessment reports for the CSP.
- Will consider in year requests for data and consultation support on the understanding this may cost in addition to the SLA

#### **Drug and Alcohol Services**

- Will prevent Harm to children, young people and families affected by Drug and Alcohol misuse
- Will deliver effective approaches to Drug and Alcohol Treatment and Social Reintegration in partnership
- Will protect communities through robust enforcement to tackle drug supply, drug and alcohol related crime and anti-social behaviour

## Youth Offending Services (YOS)

- Will act as lead agency for Youth Offending Services, including attendance at the monthly ASB casework group
- Will work with Courts to issue Referral Orders and YOS support the Panels and run the Orders.
- Will provide Intensive Supervision and Surveillance (ISS) ISS Is usually requested by YOS at Pre Sentencing Report stage or as part of a Bail support package or Detention Training Order licence. There are also strict criteria to qualify for ISS and it requires Young Person and Parental agreement and an ISS suitability assessment.

#### **Locality Teams**

- Will act as lead agency for the East Cambridgeshire Locality teams including ensuring a locality representative attends each ASB group meeting and to share information and provide updates about young people.
- Will work in partnership with other key agencies to support young people identified as vulnerable/high risk.
- Will allocate cases to Young People Workers or other roles within the locality team if felt appropriate.

# Key community consultation and engagement plans

We will work closely with Parish Councils via surveys, responsive project work, long term entrenched issues.

Will use key Voluntary Sector contacts from VCAEC (Voluntary and Community Action East Cambridgeshire) and Cambridgeshire ACRE to obtain community intelligence in order to focus service delivery.
