## **Background**

The Representation of the People Act places a duty on the Council to divide the District into polling districts and to designate polling places for each district. The Council also has a duty to keep those arrangements under review.

The Electoral Administration Act 2006 (EAA 2006) introduced a duty on all local authorities in Great Britain to review their UK Parliamentary polling districts and polling places at least once every four years. The first such review had to be completed by the end of 2007.

The Electoral Registration and Administration Act 2013 introduced a change to the timing of compulsory reviews of UK Parliamentary polling places, with a compulsory review having to be started and completed between 1 October 2013 and 31 January 2015.

Subsequent reviews must be started and completed within the period of 16 months that starts on 1 October of every fifth year after 1 October 2013. However, this does not prevent changes being made at any time before the next full review in October 2018.

The Council must conduct a review of the polling districts, polling places and polling stations for the South East Cambridgeshire parliamentary constituency that fall within the boundaries of the District of East Cambridgeshire.

### **1. Review of polling districts, polling places and polling stations in the district of East Cambridgeshire in relation to its Divisional Boundaries for County Council Elections.**

In 2015, the Local Government Boundary Commission for England (LGBCE) published its review on the electoral arrangements for Cambridgeshire County Council. The proposals set out a council size of 61 and division pattern to accommodate this number of Councillors.

For East Cambridgeshire District Council these proposals returned 8 county councillors and recommended 8 new electoral divisions.

#### **1.2 How the review is conducted**

The Council has delegated authority to conduct the review, and the legislation lays down how the review is to be conducted. On commencement of the review the Returning Officer will be asked to make his representations on existing and proposed polling arrangements. The Council will publish the Returning Officer's proposals and will invite comments. The Members will consider these before final recommendations are made to the Council on 5 January 2017

The consultation must seek comments from people who have particular expertise in relation to access to premises or facilities for persons who have disabilities.

Any elector may make representations. It is proposed that the consultation will also include local political parties, district ward councillors, county councillors for East Cambridgeshire divisions, Access Group, local MP's, returning officers for parliamentary constituencies that fall within East Cambridgeshire boundaries and parish councils.

### **1.3 The role of the Electoral Commission**

The Commission, while not having a direct responsibility for the review, can intervene where it considers that the reasonable requirements of electors or the needs of disabled electors have not been taken into account.

The following can 'appeal' to the Commission:

- Any parish council which falls within the constituency;
- Not less than thirty registered electors in the constituency;
- any person who has made representations during the review;
- any person who is not an elector in the constituency but who has sufficient interest or expertise in access to premises or facilities for disabled persons.

The Commission could direct the Council to alter any polling arrangements that arise from the review, and the Commission could make these alterations itself if the Council failed to respond within two months.

### **1.5 Making Comments**

Anyone intending to make comments is strongly urged to read the introductory comments to the Returning Officer's proposals. The Returning Officer has found that, by and large, the boundaries of our polling districts are co-terminous with the existing District and parish ward boundaries. Change for change's sake should be avoided in the review because it proves disruptive to the electors and their convenience, subsequently the Returning Officer has recommended few changes.

That said, comments are still welcomed, and an early notification where major alterations are proposed will be appreciated, because it will enable the Electoral Services Officer to enter into further and more detailed consultation where required.

Comments that support the Returning Officer's proposals are also welcomed because they will provide a balance of opinions.

Throughout the review, all working papers, minutes of meetings and correspondence will be available for public inspection at the Elections Office. All items will be published when the review has been completed.

## **2. The Returning Officer's Proposals**

### **2.1 Introduction**

The pattern of polling districts and polling places in the District of East Cambridgeshire has evolved to meet successive boundary changes to district and parish wards to divisional boundary changes and those of the two Parliamentary Constituencies, as well as to meet the convenience of electors across the district. By and large, it ensures that electors have reasonable facilities for voting. Furthermore, in line with the Council's policies, every attempt has been made to ensure that polling stations are accessible to electors with disabilities. This process is as a direct consequence of the Divisional Boundary review conducted by the LG BCE and the changes within this review reflect the new divisional areas. There are two areas within the review which will directly affect electors.

### **2.2 Guidelines**

The Returning Officer has taken the following assumptions into account when drawing up the proposals. Comments made during the consultation should keep these in mind. The first four are requirements laid down in the Representation of the People Act; the remainder are guidelines only.

- The council must seek to ensure that all electors have such reasonable facilities for voting as are practicable in the circumstances;
- The council must seek to ensure that, so far as is reasonable and practicable, every polling place is accessible to electors with disabilities;
- Every parish shall be in a separate polling district;
- Ideally the polling place should be in the polling district;
- No polling station should be shared by two wards because of the risks associated with holding different elections in the same polling station;
- Ideally there should be no more than 2,500 electors per polling district, although the number of postal voters in the district (presently about 6,500, in an electorate of 65,500) is a further consideration.
- Polling district boundaries should be co-terminous with existing parish ward or district ward boundaries.
- Where existing polling districts serve no necessary function because the electors for each polling district already vote at the same polling station, the polling districts should be merged;
- A polling station costs about £3,000 to hire, equip and staff for polling day;
- The proposals have been mindful of further development in the district as identified in the Local Development Framework.

## 2.3 The Tables

Following a summary of the proposed changes, each County Division is dealt with separately. The tables show the existing polling arrangements in each division;

- The polling district identity letters
- The polling place for the parish or parish ward
- The polling station at that place
- The number of electors on 23 June 2016 (the date of the last elections)
- Disabled access, including where this is achieved by the use of a temporary ramp.

A map showing the present polling districts follows the tables.

## 2.4 Glossary of terms

County Divisions – The division of the County into areas for the purpose of electing councillors to represent its different parts. The district of East Cambridgeshire is divided into 8 County Divisions, but the Divisions are **not** the subject of this review.

Boundary reviews – the reviews of the boundaries of parishes, district or parliamentary constituencies. Boundary reviews are **not** part of this review.

Electoral arrangements – the allocation of councillors to a council and the division of a parish or district into wards with the allocation of councillors to wards. The electoral arrangements of the parishes and of the district are **not** the subject of this review.

Parish wards – the division of a parish into areas for the purpose of electing councillors to represent the different parts of the same parish, eg the parish of Ely is divided into four wards; the parish of Coveney is an unwarded parish. The parish wards are **not** the subject of this review.

Polling arrangements – the provision of reasonable and convenient facilities for the electors to cast their votes by the division of a constituency into polling districts with polling places and polling stations

Polling district – an area in the constituency for which the electors vote together at the same polling place.

Polling district letters – three letters that distinguish the polling district and that, together with the elector's number from the register of electors for that district, make up the elector's distinctive and unique electoral registration number. The polling district letters in the part of South East Cambridgeshire parliamentary constituency that falls within East Cambridgeshire boundaries have district letters ranging from HA through to MK.

Polling place – a readily identifiable place within the polling district to which the electors will go to vote.

Polling station – the building or part of a building at the polling place, which will serve as the venue for the poll; the extent of the polling station will depend upon local circumstances.

This division will remain known as Burwell division..

A correction has been made to the name of the polling station at KB1 the original review referred to the Methodist Church when in fact we use the Baptist Church.

All of the hall contacts have reported that there are no major planned works in the next four years.

We have also received a comment from Swaffham Prior Parish Council advising us of the use of Swaffham Prior Primary School as an alternative polling station.

### The Returning Officer's Proposal

To move HA6, **HG1** and HH1 residents from the old Ely North and East division to the new Ely South division. Following the new parish ward arrangements that come into force for the divisional elections.

There will be some residents who are currently in HF1 register that will need to be moved into HF2 register so that they are coterminous with the new district and parish ward boundaries.

The electors who would need to be moved are from Allen Road, Longchamp Drive, Orford Close, Merival Way, **Turner Drive** and parts of Kings Avenue.

To replace the use of a portacabin on Davison Road with the use of a conference room at the Princess of Wales Hospital at HF2

This division will now be called Ely North division

**General Comments:** We have received feedback regarding HK1 Polling station needing to be nearer the main area of residents and possibly merged with HG1. The Returning Officer will need to conduct a further review to implement the District and Parish boundary changes and will review an alternative site or merger at that time.

**General Comments:** All of the hall contacts have reported that there are no major planned works in the next four years.

Feedback from both District Councillors that all three stations used within Littleport are large enough, easily located with parking nearby and all have disabled access. The current arrangements are suitable & adequate. The two locations in Littleport itself are reasonably near each other within Town Centre. If a voter goes to the wrong place, can easily be directed to the correct polling station, which would only be 2 minutes away on foot. There is no alternative at BHD, the Community Centre is easily found.

## **The Returning Officer's Proposal**

To move those electors in Chippenham, Fordham, Kennett and Snailwell in to the new Burwell division.

To move those electors in LG1 Soham Central, LG2 Soham South and LJ1 Wicken into the new Soham South and Haddenham division.

To move electors in Cornwell Close who are currently in LG1 register known as Soham Central into the LF1 register known as Soham North to align with the new Soham parish wards boundaries and to be coterminous with the new district boundaries.

To move one property from LF1 register to LG1 Register, namely 24 Pratt Street.

We intend creating a new register in Soham called LG3 to take into account the new parish warding; these electors are currently in LG1 register.

Those electors are from Adelaide Close, Alfreda Court, Brewhouse Lane, Brook Dam Lane, Cedar Court, Church Hall Close, Churchgate Street, Clay Street, College Road, Cross Green, Dobede Way, East Fen Common, East Fen Drove, Eastern Avenue, Ennion Close, Fountain Lane, Frederick Talbot Close, Odds of Gardeners Lane, High Street, Hodson Close, Kents Lane, Lines Close, Lode Close, Market Street Mews, Market Street, Odds of Mill Corner, Mynott Mews, Paddock Street, Pratt Street, Ranthorne Mews, Red Lion Square, Regent Place, St Andrews Park, Staploe Mews, 1-63 Odds of Station Road, Thomas Mews and White Hart Lane.

We also intend moving some of the existing LG1 electors into LG2, again to be coterminous with the new parish warding.

The remaining electors from LG1 are: Berrycroft, Fairfield Close, Evens of Gardeners Lane, Guntons Close, Harrison Court, Mereside, Evens of Mill Corner, Evens of Station Road, West Drive Crescent, West Drive Gardens and West Drive. This will form the parish ward called Soham Central.

The electors of LG1 and LG2 currently vote at Walter Gidney Pavilion and we see no reason for this to change.

We intend to make it easier for the electors whereby we will have one polling station within the Walter Gidney Pavilion building for each of the three registers. LG1, LG2 and the new LG3 register.

The LF1 Soham North register and the LC1 Isleham register will form the new division called Soham North and Isleham.

Those electors who are in JA1 Haddenham, JB1 Aldreth, JD1 Stretham, JF1 Little Thetford, JH1 Wilburton, LG1 Soham Central, LG2 Soham South, LG3 Soham South and LJ1 Wicken will form the new Soham South and Haddenham division.

### The Returning Officer's Proposals

To take in those electors from Swaffham Bulbeck parish from the old Burwell division.

There are no proposals to change any of the existing registers or polling stations within this division.

The division will remain named as Woodditton division.

**General Comments:** We have received feedback from a resident regarding the need to use threshold ramps at Bottisham, and also commenting on crowding during busy periods (4.30 to 8.30) and also commented on the use of the two schools if the RBL closed.

## General Comments

Please note that we are aware of the following issue at our polling stations that do not fall within the remit of this review:

Gravel driveway/car park at Coveney is not ideal for people with mobility problems.

Mepal Village Hall car park needs some improvements to surface, i.e. potholes.

Access to polling station at Lode is poor, minimal parking for disabled electors, car park surface not good for anyone with mobility problems.

**General Comments from the Review:** We have received feedback from a resident that they do not like some of the proposed boundary changes, eg splitting the 2 Swaffhams, but they accept that the Boundary Commission are always facing awkward decisions where population does not match geography conveniently. Any chance of emphasising the suitability of postal voting among the remote farm dwellers and the National Stud houses inhabitants.

The City of Ely Council: members were happy with the proposals for Ely within this consultation. However, the facilities provided for the polling stations need to be fit for purpose, as in the past this has not always been the case.

We have received feedback from the Access Group: We are grateful that Democratic Services have made considerable effort in the last few years to make polling stations and voting procedure, on election day, accessible to all as far as is reasonably practical:

Could you tell us the following:

1. Are there any new polling stations or changes to current polling stations? If so, do they meet the standard you require, - eg parking, level access, signage, unobstructed entrance etc?

2. Were there any complaints about access after previous elections? if so have they been addressed? We have received no complaints.

We are assuming that there are always at least 2 clerks at the polling station so someone is available to offer help if necessary. – **Our response was:**

There have been a couple of changes to polling stations recently, we no longer use the Cherry Tree Public House and these electors go to The Walter Gidney Pavilion but in a separate room, and Walter Gidney are currently doing some improvements to the access. We also moved the polling station in Burwell from the parish reading rooms to the Baptist Church which seems to work better, as there is more space available for the growing electorate.

We now use the larger room at the Methodist Church in Ely, and Soham Town Rangers Football Club both for better access and for the growing electorate. We feel that they meet the standards but we do send out polling station inspectors for each election to address and report back any issues.

We did not receive any complaints about access after the elections but have already received one comment for the review regarding access at Ely Methodist Church, we can address their concerns regarding signage but have forwarded the comments regarding street lighting on to the County Council.

Some of the smaller polling stations only have one clerk and the presiding officer but they are all trained to offer assistance if necessary.
