TITLE: REVIEW OF ANIMAL LICENSING FEES.

1.0 ISSUE

1.1 To propose revised licence fees for the Council's statutory animal licensing function.

2.0 RECOMMENDATION(S)

2.1 That Members approve the proposed fees and charges.

3.0 BACKGROUND/OPTIONS

- 3.1 Animal Licensing is a statutory function, covered by a number of different statutes prescribing the licensing, administrative process and conditions to be attached to animal licences.
- 3.2 The Council licences and issues a number of animal licences on an annual basis (Appendix 1)
- 3.3 The initial and renewal application process for many of the animal licences requires a visit to be made to the premises to determine the application.
- 3.4 Many of the premises also require an 'in year' visit to assess compliance with licence conditions, in addition to visits to investigate complaints or allegations about a licensed premises.
- 3.5 Such visits involve travelling time, investigation time and then relevant follow up action, such as the compilation of informal warning notices, or the gathering of evidence for Simple Cautions or prosecutions.
- 3.6 The administrative process involved in sending out annual renewal applications, chasing up late applications and creating and issuing licences, as well as maintaining files and computer records also forms part of the animal licensing process.
- 3.7 Several premises within the District have a history of non compliance with licence conditions, and as such, result in more time being spent on inspection, following up complaints and investigations, and in several cases, gathering relevant evidence for legal action.

- 3.8 A review of the administrative and officer time connected to the different types of animal licence issued by the Council has been calculated.
- 3.9 At present the Council requires the applicant (where relevant) to arrange for a veterinary inspector to carry out an inspection and submit a report prior to a licence being issued or renewed. This cost is borne by the applicant. It is proposed that the Council review this current practice over the next year, with a proposal to authorise a veterinary inspector to carry out the inspection on licence application and renewal stage where required by legislation.
- 3.10 The proposed licence fees are set out at Appendix 2

4.0 ARGUMENTS/CONCLUSIONS

- 4.1 It is important that the level of licence fee reflects the officer and admin time spent in the renewal, application, issuing and in year activity associated with a licence.
- 4.2 For brand new applications for animal licensed premises, a higher fee has been set to account for the more detailed inspection required to offer initial advice and information and where necessary, a further inspection prior to the granting of a licence.
- 4.3 The currently licensed premises will therefore be subject to the proposed revised renewal fee, rather than the higher proposed fees for brand new premises.
