OBJECTION Kebab Van Brookland Car Park, Sutton

Both myself and my husband are residents of Sutton Village and it has come to our attention that the Parish Council and the District Council are considering licensing a Kebab Van to sell 6 days a week in the Brookland Car Park next to the British Legion. This area is the heart of the village, the school, the British Legion club, the village hall, the bowls green and the Pavilion are all here. It is not appropriate for a Kebab van to be sited there

The increase in traffic in the car park from the village and surrounding villages will make it difficult for users of the other amenities sited there. The entrance to the car park is on a corner which is dangerous enough as it is. There may be lorries and vans which decide to use the Kebab van, which will make it even more dangerous A kebab van will attract more teenagers and young people, to this part of the village where there are all ready problems with vandalism and groups collecting. The older members of the community will certainly be feeling nervous at night and may not attend one of the community facilities to avoid these groups.

Street Trading consent for Kebab Van to be sited at Brooklands Centre Car Park 6 days a week 16.30 to 22.00 hours and extended hours Christmas Eve & New Years Eve.

We have received your letter dated 1st December 2017 and would like it on record that we strongly object to the siting of a Kebab Van at the Brooklands Centre Car Park.

There are significant issues with this for us as residents who will be directly affected.

Visibility

The van will be visible from our rear garden, lounge windows/doors and our back door (and of course all upstairs windows).

Previously there was a burger van sited there without proper licensing, which we objected strongly to (we contacted the Parish Council who did nothing !!) and to avoid seeing it we spent not inconsiderable sums of money raising the eye level of parts of our garden fence and putting in flowers with a strong scent but we could still see the van and suffer unpleasant cooking smell's

Noise

There will be significant noise pollution from the Kebab Van from cooking, power generator and patrons ordering and collecting food.

The Parish Council have already refused permission at other points in the village due to parking issues, so it is acknowledging that there will be an increase in the number of cars entering and leaving the car park. This again will impact on us environmentally due to noise of these additional cars and associated noise, such as car stereos'.

Sutton already has a problem with the amount of large vehicles and HGV's passing through the village. There will be no controls on the car park to stop larger vehicles using it, so it could effectively become a 'truck stop'.

Our pets will be constantly disturbed by the noise so will be vocal in dealing with what they perceive as a threat so will not settle, do we have to them keep them inside all the time the Van is open. How do we do that in the summer other than closing all doors; with the smell these and our windows will have to be shut anyway!!

Smell

Offensive smell from the cooking that will take place in the Kebab Van; this will spread into our garden and will permeate our house, unless all windows and doors remain shut; this is certainly unacceptable during the warmer months when we wish to enjoy our garden and open our windows, hang washing out for example. The opening times of the Kebab Van requested directly coincide with the times that we would use our garden the most and for 6 days a week!

Rubbish

There will be an impact on the immediate environment of rubbish (paper & polystyrene), not only in the Brooklands Car Park, the pavilion area, but the football field, the children's play area and in our garden.

Waste food will encourage vermin into the immediate local environment

Meeting Point

The Kebab Van will encourage adolescents to meet in the vicinity with the associated noise and potential anti social behaviour. There have been issues with vandalism at the pavilion to the rear of the Brooklands Centre and the Van's siting will encourage teenagers to meet there. In addition whilst the Van may open till 10pm the associated noise will continue for some time after that time which is unacceptable as a neighbour.

Local Residents

There are not only housing residents in the immediate vicinity that will be affected, the car park is used by the School, after school clubs, general sporting activities on the sports field, the Sports Pavilion and there is a Bowling Green used by the older members of the community. Is the siting of a Kebab Van appropriate outside these venues what message does this send to our youth with

unhealthy eating and the potential to upset older members of the community with groups of teenagers and adolescents gathering in the vicinity

The Parish Council and the District Council need to understand how our garden is extremely important to us; over the last few years my wife and I have unfortunately had to deal with serious illness (cancer) and the garden has been key in assisting with our recovery from serious operation's and chemotherapy treatment. We accepted when we purchased our property that there would be some noise from the British Legion and have tolerated additional events held there and in the playing fields which create noise, but these are irregular. This licence requested is for 6 days a week, so there is no respite whatsoever for us as residents, it is effectively a permanent food outlet.

We find it disturbing that the Parish Council apparently discussed this back in July this year, but at no time thought it appropriate to approach us as residents to gauge our views as those that would be directly affected. Interestingly we understand that a licence to trade as a kebab shop at the site of the now 'Deli café was refused a number of years ago, why then should the Brooklands Car Park be any different, the environmental issues for residents are the same, smell, noise, rubbish.

The minutes to the Parish Council meeting on 25th July 2017 that originally considered and discussed the application are stated as 'The Council are in favour of new business starting up in the village however a permanent hot food van is not appropriate for this site'. In those same minutes they also highlighted parking issues in the Car Park and also 'They had concerns over the noise, smells and mess that may be left on the site that is owned by the Parish Council'. Yet in the August meeting the application was discussed again and approved for a 6 month trial! The issues were still the same and still none of the residents that will be affected have been consulted or considered.

There may be people in the village who are in favour, but how many of those are willing to have it sited near or next to their properties. We have already had it confirmed by a local estate agent, that the saleability of the property will be affected adversely by this licence being granted. The siting of the Van so close to us effectively amounts to a 'blight' on our property.

All these points above, makes the granting of a licence extremely detrimental to us as residents. There are sites on the edge of Sutton that are not near residential housing, the Kebab Van could be sited at one of these, as there would not be any direct negative impact on residents.

- Bungalows are predominately in the area, no more than bungalows should be built on this site.
- The bottom end of Garden Close is below the level of the field.
