- 3.2 Issuing the above suspension notices gives the licence holder 21 days to resolve the issue before the suspension becomes active. The above shows that only two of 26 notices took effect.
- 3.3 In addition to the suspension notices issued above Officers the following immediate suspension notices for vehicle MOT failures.

Taxi driver – enforcement action	1	0
Taxi vehicle – MOT failures	12 out of 81 tests	3 out of 89 tests

3.4 Although Officers would rather it be the case that no notices had to be issued, the number of notices being issued remains within acceptable levels.

Taxi Rank update

- 3.5 Members will be aware that on the 17 May 2017 it was recommended to Council that the alternative rank proposal should be progressed. Council approved this recommendation on 13 July 2017.
- 3.6 By way of an update, the third party Traffic Regulation Order (TRO) has been submitted along with the provisional fee of £250. Officers have been advised that Cambs County Council (CCC) are working on the preliminary site drawings for ECDC approval, and that these should be with Officers by the 2 October.
- 3.7 Once these have been signed off, a 21 day consultation on the TRO will be conducted by CCC.
- 3.8 Indications suggest that the works should be completed by early 2018.
