

I am writing regarding the extension of the Market street taxi rank because this has become a crucial issue. The taxi rank should be extended at least from Chequer Lane and I suggest to create more 1 or 2 "waiting" spaces before the Costa Coffee corner from where is possible to see whether the space on the taxi rank is available or not.

Firstly, if you take into account the number of licensed taxis in East Cambridgeshire, the main taxi rank in the center of Ely (and compare to the station taxi rank) provide insufficient space just for four cars (or five small cars).

Secondly, the most of the taxi drivers rely on how many jobs they pick up. A taxi available for hire needs to be parked on the place determined to picking up. Parking in a different place than on the taxi rank is wasting of time. Taxi rank should provide enough space for drivers to allow them to do their job and make enough money for living. The extension of the taxi rank will support more equal opportunities to get a job.

Thirdly, driving around in circles Market Street – Lynn road – Nutholt Lane – Newnham Street in order to get a space on the taxi rank causes increasing of petrol/diesel expenditures and decreasing of income. In addition, it increases a probability of being involved in an accident.

Fourthly, insufficient space on the taxi rank support rivalness, unfair and mean manner among drivers and companies and the relationships among companies and drivers are getting worst. This can lead to a high amount of unnecessary, silly, or unreasonable complaints that the license office will have to deal with. For example, today as I was coming up to the taxi rank I noticed through another driver's window that he got a job on PDA and I decided to pull in the taxi rank when he pull off the rank. Unfortunately, he did not want to proceed the space to me as another car of the same company was waiting on double yellow line before the Costa coffee corner. I had to wait couple minutes until he proceeded the space. And this is not correct.

Fifthly, I disagree with those who argue that the taxi rank extension will take public spaces. Reasonable space on the taxi rank will stop taxis to park elsewhere on public spaces on Market street when they cannot get in the taxi rank.

In conclusion, in respect of license fee we pay, the license office should extend the taxi rank to support more equal opportunities, safety, business growth and good relationships among the companies and drivers.

I believe that this will help to improve our working environment significantly.

With 121 licensed Hackney carriages in the ECDC area, and a limited number of designated taxi rank spaces, any increase would be fully supported by all at A10 Taxis Ely.

Further to your Licence Holder News item regarding Market Street Taxi Rank I have the following observations:

- Extending the rank is a good idea
- There are a number of taxi drivers that will use other areas of Market Street in preference to the rank currently, typically ahead of the rank, and presumably that will continue to be the case. In the evening it is not unusual to see the taxi rank empty or with just 1 vehicle and yet there are several taxis in the bus stop area.
- There are a number of non-licenced vehicles that are happy to park on a taxi rank. There are times when both of the County ranks in Ely are fully occupied with non-licenced vehicles.
- In my experience it is rare to pick up from the Market Place rank, especially in the evening. Therefore it is understandable that some taxis would rather wait off rank in Market Street rather than proceed to the Market Place rank.
- In general the public don't understand taxi legislation. They don't particularly pay attention to the roof sign
  or the location of the vehicle. It is not unknown to see people waiting at a bus stop after hours for a taxi, or
  for them to walk past all of the taxis on the rank and get into one at the bus stop. Also they will walk along
  the rank and choose a taxi other than the one at the front.
- I would suggest that perhaps together with the extension to the rank, that changes be made to allow taxis
  access from High Street through Market Place and onto the Market Street rank. With this facility taxis
  would be able queue in a formal manner with customers being encouraged to take the front taxi.

Thank you for picking up 'the cause' even though it is not your responsibility, we appreciate the work you do for Taxis in our region.
