Hi,	
We are responding to the consultation regarding the proposed variation of the taxi rank on Market Street, Ely. We respond as both residents of East Cambs, and running a business on Market Street.	
In principle, we would like to support the proposed change to extend the taxi rank, because taxis do already try to park on the corner by Costa, so giving them slightly more space in the proposed area seems sensible.	
However, there are very regularly several taxis/private hire vehicles parked in some of the other existing 30 minute parking bays on Market Street, as demonstrated in the attached photos looking each way along Market Street which show 4 "public" spaces taken by taxis, with the photos taken at 12:57 on 2 nd Feb 2017 (2 taxis by the photographers/butchers, 1 by Fencabs and 1 by Citizens Advice Bureau, in addition to a full taxi rank). A similar photo could be taken at various times of the day, on most days of the week. And taxis often park for more than 30 minutes. Therefore currently "public" parking on market street is negatively affected even by the existing taxis.	
Therefore it would seem sensible to us, to combine the proposal of extending the taxi rank, with implementing a ban on taxis from parking in the 30 minute "public" parking bays. To ensure this is complied with, we'd suggest that this be done by ensuring that all licensed taxis/private hire vehicles explicitly have in the license terms that they will lose their license if they park in the "public" 30 minute parking bays on Market Street. Ideally, to be effective, this would be implemented with a "1 strike and you lose your license for a year", based upon a photo from CCTV/a member of the public, since the taxi drivers will always be able to move their car before a traffic warden arrives, as they know which days the wardens are in town, and when they're coming!	
If done as a combined change and with a suitable risk to the taxi drivers of losing their license for a year if they do park in the public pays, this would both give the taxis more official parking in the taxi rank, and increase the availability of 30 minute bays to the general public. Since both areas seem to be within the remit of the Licensing department, this should be possible to implement relatively easily?	
So as we say, we would like to support the extension of the taxi rank, but our support is conditional upon taxis not being allowed to park in public bays. If banning taxis from parking in public bays is not possible, then we would object to extending the taxi rank, since taxis are already making excessive use of existing public bays on Market Street.	
We hope that is a constructive input to the consultation, that may give the taxi drivers what they wish for, and also benefit the public.
