| 1   | <p><b><u>Littleport Community Primary School</u></b></p> <p>Recycling vehicles that empty the recycling banks opposite the school have been parking on the yellow zig zag markings on the road whilst they service the banks. This is illegal. The school caretaker has had an unpleasant altercation with one of the drivers of a recycling vehicle when he challenged his parking.</p> | <p>The contractors responsible for emptying the recycling banks have been contacted accordingly and asked not to empty banks near schools during busy periods, also all drivers have been reminded they should not be arguing with the public and any issues should be referred back to the Council for resolution.</p>  |
| 2   | <p><b><u>Woodfen road</u></b></p> <p>Fencing work, when to be carried out.</p>   | <p>We are awaiting a start date from contractors and Officers will update the Panel when this is confirmed.</p>  |
| 3   | <p><b><u>Across Panel area</u></b></p> <p>Bird scarers going off early AM. Breaching regulations by going off at 4AM? Details needed about which fields they are going off in</p>  | <p>Standard guidance is available from the NFU in a bird scarer's code (sample copies available). Environmental Health offer advice and guidance only to farmers. There are no statutory provisions against the early sounding of bird scarers. Most of the scarers are light triggered which is why then can go off early in the summer mornings. However, the units can be adjusted to go off earlier and it is this advice that is provided by Environmental Health at ECDC.</p> <p>To provide this advice ECDC Environmental Health would ideally need the name and address of a farmer or at least a precise location for where the noise is originating.</p> |
| 4   | <p><b><u>Beech court</u></b></p> <p>Access area fly tip for garden waste. Cannon Kirk owner.</p>   | <p>ECDC will only investigate issues of fly-tipping on public land and these issues should be addressed to the Council directly either by e-mail, phone or via the online portal at the time of the incident.</p> <p>Any fly-tipping on private land is the responsibility of the land owner.</p>  |

| 1   | New lighting and black spots at Longfield Road and the Crescent     | <p>The street lighting for these two roads has been replaced as part of the street lighting PFI replacement programme being undertaken on behalf of the County Council by Balfour Beatty; this programme includes removal of a percentage of street lights in residential roads across Cambridgeshire.</p> <p>The areas where streets lights are not replaced do experience a lower level of lighting, which could be described as “dark spots”.</p> <p>Balfour Beatty will check to ensure that all of the street lights in these roads are working correctly when they next visit that part of the County.</p> <p>Balfour Beatty is currently discussing with District Councillor Morrison the options for Longfield Road, Littleport.</p> <p>Balfour Beatty has informed Councillor Morrison that it would be possible to reinstate the column which was removed from Longfield Road but this result in the need to remove another column in Littleport when Balfour Beatty undertakes the rest of the works in the town.</p> |
| 2   | Overgrown at Friars place onto footpaths. Hedges spread onto paths. | <p>In most cases, boundary hedges or planted shrubs adjacent to the public highway are in the ownership of the respective adjoining property owners and, therefore, the responsibility to maintain this planting (to ensure that there is no obstruction to the highway) rests with those property owners.</p> <p>However, the County Council, as Local Highway Authority, will, as a matter of priority,</p>  |

|   |  | <p>send letters to the property owners, to both remind them of their duties and request that they trim back the hedges and/or shrubs.</p> <p>The relevant officer within the Highways Service is seeking to clarify ownership issues and will arrange for any clearance work/trimming to be done as required.</p> |
| 3 | <p><b><u>BP garage</u></b><br/> Pedestrians and cars near misses. Crossing set back. Blocked view of cars from petrol station. Can crossing have black bars (zebra crossing markings)? Cars come off roundabout and pick up speed! Problem for Wisbech Road.</p> | Awaiting update from County Council Highways.   |
| 4 | <p><b><u>Parsons Lane</u></b><br/> Drainage gullies in the vicinity of the cemetery are "sinking"</p>  | Cambridgeshire County Council's Local Highway Officer for the area is investigating the issue.  |
