his is the last ever South Neighbourhood Panel newsletter. A decision was made by East Cambs District Council that, following the January 2014 panels, no further neighbourhood panels would be held because a review had shown clearly that they do not provide an effective means of engaging with residents and responding to issues in local communities. ShapeyourPlace for example, now provides a response to an issue within 10 days (rather than having to wait three months for a panel meeting), and many parish council's regularly engage with residents for their issues and priorities.

This newsletter summarises the key issues raised at the final South panel held on 28th January 2014, and provides responses to all of the issues raised apart from the Policing priorities where an update will be posted on www.shapeyourplace.org by Mid April 2014.





#### **Town and Parish Councils in East Cambridgeshire**

Town and Parish Councils are the first tier of local government, having certain responsibilities for much smaller geographical areas than a District Council or County Council; many such councils cover only one village or town. They can play a vital role in improving the quality of life and the local environment in the communities they represent.

Town and Parish Councils not only focus upon more localised issues but also seek to influence the upper tier councils and other agencies. Many Town and Parish Councils work in partnership with other agencies and authorities to achieve ambitions for their local communities.

These councils set their own budget each year; they are statutory consultees on planning applications relating to the area that they represent; they have powers to provide (and maintain) a number of facilities, including: bus shelters, playing fields, play equipment, community buildings, allotments, cemeteries, war memorials, other recreational and leisure activities.

Some local councils, where eligible, have adopted the General Power of Competence (CPC); this power was introduced in the Localism Act 2011 (sections 1 to 8

inclusive refer). The GPC gives local authorities "the power to do anything that individuals generally may do" as long as they do not break other laws. It is a 'power of first resort'.

The importance of these local councils will increase as the financial resources of the District Council and County Council continue to reduce. For example, a number of local councils now meet the cost of operating a youth club, undertake the cutting of highway verges and are providing funding for minor highway improvements (such as changes to speed limits and introducing parking restrictions).

# Recycling up to 54 per cent following wheelie bin roll out

The new wheeled bin recycling service in East Cambridgeshire has made an instant impact with the district's recycling rate leaping up by over 20 per cent.

Between October and December 2013, over 3,864 tonnes were recycled in East Cambridgeshire - this compares to 2,293 tonnes over the same period in 2012. This equals a recycling rate for the district of 54 per cent in just three months of the new recycling system.

Feedback obtained since the roll out of the new services also suggests residents believe they are recycling more since they received their wheelie bins. 83 per cent of respondents said they were recycling more with their blue bins, while 57 per cent said they were recycling more garden and food waste.

In order to maintain this momentum the Council is continuing its promotional campaign by visiting local primary schools and holding roadshows in market towns across the district.

The new recycling service involves:

A blue lidded wheeled bin recycling collection,





including paper, glass, food & drinks cans, plastic bottles & hard plastic food containers, cartons and cardboard. This will be collected fortnightly.

 A green lidded wheeled bin collection for garden and food waste. This will also be collected fortnightly.

Refuse in black sacks continues to be collected weekly with the annual supply of a household's black sacks delivered with the new wheelie bins.

These changes are possible after East Cambridgeshire District Council successfully bid for £5 million from Central Government to fund a new recycling service and retain weekly waste collections last year.

## Issues raised at the January meeting

There was one policing priority raised at the panel as follows:-

Acquisitive Crime across the Panel area

The Police need a minimum of 3 months to tackle and respond to these issues therefore an update will be provided on www.shapeyourplace.org in Mid April 2014.

#### **Cambridgeshire County Council**

Issue 1: Pavement on North Street, Burwell – level with the road and very narrow. It is very dangerous for

pedestrians especially as there is no curb to distinguish between the road and the pavement. No's 9, 11, 15 & 17 and opposite 12 & 12a. Please can action be taken to address this.

#### Response/action:

Section from 9-12

- The width of the footpath is 1.7m
- There is a kerb at this location, however, this is a dropped kerb.
- If a full face kerb were installed at this location, it would alter the fall towards the properties, which would then cause problems with surface water.



- The current up-stand for these kerbs is a maximum of 15mm. It may be possible to increase this to 60mm, however, much more that this could result in surface water flowing onto private property.
- This section of footpath is of modular construction, any alteration in the surface would be labour intensive (expensive).
- Bollards in the existing surface may be more appropriate/effective if local residents do not object.

#### Section opposite 12a:

- Very narrow (approximately 0.5m)
- This is due to the corner of a private (possibly listed) property
- There is insufficient room to carry out any alteration at this location.

Issue 2: Campaign to have a cycle path from Quy to Lode is starting. Feasibility study has been completed and there are now 3 options. Anyone interested in learning about the options should contact Lode Parish Council. Concern that there is a lack of cycle infrastructure and whether there are opportunities to improve it in the general South of the District. Would particularly like to hear from Burwell and Swaffham Prior to see if there are any opportunities for joint working. Also are there any opportunities for drawing down government money.

Response/action: The County Council's Cycling Team is aware of the local appetite for a route from Lode and

has been in touch with the Parish Council on a number of occasions.

The route will feature in the Transport Strategy for Cambridge and South Cambridgeshire (insofar as part of it is lies within South Cambridgeshire) and the remainder will appear in subsequent strategies.

Currently there is no source of funding for this, a point that which has been made on a number of occasions.

Issue 3: Route 51 (Sustrans route) Cambridge – Newmarket – It would help if the path that runs parallel to the A1303 if at the turning at Bottisham if the cycle path could be extended along there it would be much safer and encourage more users.

Response/action: See Issue 2 above.

Issue 4: Figures are needed to show how many people are using the subsidised bus routes to help inform parish council responses to the Future Transport consultation/engagement process.

## **Action on Energy Insulation Grants**

Cambridgeshire Councils have been awarded £5.67m Green Deal Communities funding by the Department of Energy and Climate Change to help residents install insulation improvements to older and non-standard properties.

Typically older and non-standard properties have been considered more expensive to insulate, but can often suffer the most from being cold, however this funding will provide an opportunity for residents to make

improvements at a greatly reduced rate, using grant funding, plus the Green Deal.

Funding will be available for private rented houses, those off the gas network and those in conservation areas across Cambridgeshire. If you live in a property like this, and think your home needs insulating, we would be keen to hear from you.
